A few months ago, you reached out to me stating that you were going to do a Change of Manager for The Brown Jug, as a result of the passing of Mr. Charles Lajoie, Jr., which was almost two years ago; as well as for Lebeau’s Tavern (This office has also been made aware that Mr. Kenneth J. Rapoza is no longer the manager, and has not been for a long period of time.) As Chairman Beauregard was signing the liquor licenses for ‘2020’ in preparation for our renewal season, he noticed that Mr. Lajoie’s name was still on the Brown Jug’s license and Mr. Rapoza’s name is still on the Lebeau’s license.

Based on that information, the Chairman requested that I notify you of the required change and request that you appear before the Board at its next scheduled hearing on October 21, 2019.

It would behoove you to submit applications in time for this meeting date for both locations, so that they may be considered by the Board for approval at this meeting. The applications would have to be submitted by October 14, 2019, so that they may be placed on the 10/21/19 Agenda.

Please be advised that you have until October 14, 2019 to submit applications for those changes previously referenced.

Please note that you are in violation of the following regulations that will require the Board to act.

MGL Chapter 138, sections 12, 23-

An application must be filed to obtain approval from the local licensing authorities and the ABCC for a change of manager.

12. A Request to Be Heard

A written request was submitted by **Zamora & Family, Inc. d/b/a Freddie’s Café, 175 Sawyer Street** asking the Licensing Board to restore their operating hours back to those allowed by law. Mr. Zamora stated that he has been in compliance with keeping his establishment trouble free and would like a second chance of running the bar with later hours; and will try his best to keep it trouble free.

Board’s Written Decision of 02/27/19

Per your hearing of Monday, February 25, 2019, it was the Board’s decision to decrease your hours of operation and amend your Common Victualler (Restaurant) All Alcoholic Beverages License **to reflect an 11:00 p.m. closing. This decrease in hours will be in effect for a minimum of six (6) months, at which time you may submit a written request to have your full hours of operation re-instated; which will require the Board’s approval. This decision shall take effect on Monday, March 4, 2019.**

The reduction in hours is non-appealable under M.G.L. Ch. 138, sec.12.

This decision is the result of complaints reported by the New Bedford Police Department as well as numerous occurrences of late-night disturbances involving alleged violations of Massachusetts General Laws, Alcoholic Beverages Control Commission Regulation 204 CMR 2.05 (2), and New Bedford Licensing Board Rules & Regulations.

Upon proper notice and hearing, this Board concurred that based on the increase and frequency of incidents that have occurred after 11:00 p.m. that have required police involvement at your location, which include incidents resulting in patrons being assaulted, patrons being served to intoxication, and reports of overcrowding; as well as allowing objectionable persons on the premises; which have often resulted in late night disturbances at closing time.. We do not take decisions affecting the financial resources of any establishment lightly, but we have an absolute obligation to make sure all licensed establishments are safe to the general public.

The Board’s decision shouldn’t affect or inhibit your ability to earn revenue if you function as you originally put forth in your plan to this Board, in which you stated that you would operate the restaurant in the same way that it has in the past, and that it will primarily operate as a restaurant, not as a bar.

We would also like to take this time to remind you that it is your responsibility as a licensee not to permit any illegality to occur on the licensed premises, and that you are responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises; to wit, alcoholic beverages shall not be served to a person who is or appears to be intoxicated; objectionable persons shall not be permitted on or about the premises, and it is the responsibility of the licensee to enforce this rule; premises must at all times be kept safe.

We understand the difficulties associated with running liquor establishments, so we ask that you do your due diligence in providing a clean, safe, and friendly environment for your patrons to enjoy.

Please understand that within 15 minutes after your 11:00 p.m. closing glasses, bottles or containers used for drinking purposes must be off the tables and bar and no alcoholic beverages may be served or consumed at the expiration of 15 minutes after closing (11:15 p.m.). **All patrons must leave the premises no later than 11:30 p.m.**

As I trust you are aware, your responsibility to your patrons is not just confined to the interior of your establishment but to the exterior area adjacent to your establishment as well, especially if it involves an incident involving your patrons. The reports before the board also indicate a frequency of high levels of intoxication amongst those causing the disturbances, as well of incidents involving minors. Per the instructions of this Board, all servers are required to be TIPS certified and therefore cognizant of the signs of intoxication.

Your presence before the board is in the form of a meeting and not a hearing with the hope that we can have a meaningful dialogue in addressing the number of complaints involving your establishment.

I kindly ask in preparation of this meeting that you give some thoughts to your current business plan and your thoughts towards customer safety going forward.

Also, you are required to present to the Board that evening a written "Security Plan" (6 copies), which must include your hours of operation, type of entertainment (if any), the number of security of personnel and the days and hours that they are on duty; as well as your kitchen hours, if operational.
