It has been brought to our attention that patrons have been observed smoking and drinking out of glass containers without the required presence of staff in the outside area. Additionally, if the establishment does not have an operational kitchen, then any use of the outside area is prohibited. Please note the following:

City Ordinance Chapter 15, Article VI - sec. 15-100 - Outdoor café permit

- (ii) No portion of an outdoor café may be used for any purpose other than seated dining or circulation. Outdoor cafés must serve food. No one shall be seated in an outdoor café for the sole purpose of drinking alcohol, nor can the outdoor café be used as a place for patrons to drink while standing.
- (iii) The outdoor café area cannot be used for smoking.

You are requested to bring with you your Sidewalk Café License to the hearing as you may be required to relinquish same depending on the Board's findings.

Present: Jason P. Lanagan, Owner: Damon Chaplin, Director of Public Health

Chairman Beauregard opened the hearing by asking Mr. Lanagan as to the status of the kitchen, to which Mr. Lanagan responded, the kitchen is now open ... we pulled plumbing and electrical permits and that work has been completed ... the kitchen is now functioning ... we're currently serving a seven item menu which will be changing every week... we did open the kitchen which was always our intention ... the reason we weren't open was due to the fact that we had a ventilation issue that we had to deal with ... then our tenant decided to move out next door ... so our plans changed ... so we kind of got caught up in all that ... so we got caught in this time frame where we we're not totally functional ... but it has been remedied 100% since the violation notice.

When asked by Chairman Beauregard, so that allows you to serve food outside, Mr. Lanagan responded, yes it does ... we've retrained our staff ... we've added signage outside that lets the patrons know what the rules are ... and everybody seems to be following the rules 100% ... I check in periodically unannounced to make sure everybody is doing the right thing ... smoking has never been permitted ... however, people weren't enforcing those rules ... but they have been retrained ... it's become a much more serious issue ... we've purchased more than enough plastic drink glasses ... to ensure that all drinks are being served in plastic glasses ... like I said earlier ... we take this very seriously ... we're very proud of what we do down there ... so we've done everything we can to fix this.

Mr. Damon Chaplin, who is the Director of the Health Department was then recognized by Chairman Beauregard, who stated, they currently do have a permit to operate the kitchen ... they have a Health Permit for the bar only ... we have not received an application for the kitchen ... so they're operating without a permit ... and the second thing is ... the bar permit expires June 30th ... and we have not received a new application which was due in May for the health inspection. Mr. Lanagan responded, so, if I may ... I did reach out to the health inspector immediately after being cited ... and I met with the health inspector on site ... and went over everything that we would be doing ... and I asked him if I should fill out the application at that time ... and he told me to wait and to submit them both at the same time ... and that's what I'm doing ... I'm more than happy to get that application in tomorrow ... we made sure that more than one staff person is ServeSafe Certified ... as well as getting the Allergy Certificate ... and CPR Certifications ... so I can easily have that application filled out 100% tomorrow ... but I did meet with an inspector down there.

When asked by Mr. Chaplin as to when he met with the inspector, Mr. Lanagan responded, it was the week after Memorial Day Weekend, which was the weekend I was cited on.

When asked by Chairman Beauregard if what Jay just described is the problem as to why you can't issue the permit not the renewal but the permit for the kitchen and because of everything you just mentioned, Mr. Chaplin responded, that's correct ... we haven't received an application, which we would need to initiate the inspection of the facility ... so we can't issue the permit without first inspecting the facility, which we would do once we receive the application ... so, in a couple of weeks even the bar permit will be expired.

Chairman Beauregard responded, so the problem is ... if the kitchen isn't operational ... then the patio cannot be operational.

Mr. Lanagan responded, like I said earlier ... I did call the inspector to come down ... and I do understand what you're saying and that will be the first thing I do tomorrow morning to bring it all together ... but it wasn't something that I was trying to skirt around ... I have two other restaurants that filled out their applications and got them in on time and that's when I called ... and told them that I was submitting my applications for "Cork" and "Rose Ally" at this time ... and I have this situation going on at "Cultivator" ... finish everything ... get it up and running ... and then fill it out ... so that's really where I'm at now.

Mr. Chaplin responded; "you can't be serving food while that process is happening".

Chairman Beauregard responded, with that said ... where we're at now is ... the outdoor patio cannot be operational until you receive your food permit, so you need to surrender the patio license that we issued to you until such a time as you are issued your permit from the Health Department.

When asked by Chairman Beauregard, so how long is the turnaround time to get a permit issued? Mr. Chaplin responded, it's just a matter of scheduling an inspection once we receive his application ... and we don't know what we'll find once we get in there.

Chairman Beauregard informed Mr. Lanagan that, based on the information provided by both him and Mr. Chaplin, that use of the outdoor patio is prohibited until a food permit is received and submitted to Mr. Nanopoulos.
