This hearing will focus on the control and operations of the licensed premises, as well as your failure to secure a Certificate of Good Standing from the Department of Revenue in a timely manner, which is required to complete your application for a Change of Officers, Directors, and Manager, which was tabled at this Board's 08/26/19 meeting. The Board is deeply concerned that you have been operating without an approved manager since January 23, 2019, as well as your failure to resolve your outstanding issues with the DOR in a timely manner.

Short of full compliance, the Board must take action and **as such you, are hereby ordered to bring with you your 2019 Liquor License.** Depending on the Board's findings, you may be required to surrender your license until this matter is resolved.
