Chairman Beauregard opened the hearing on the petition by stating, the changes being requested are pretty routine for the Board but the main reason we wanted you to come in tonight is to get an update as to what is going on late night in your establishment ... I know you have police details but we're still getting some complaints through Capt. Sousa ... there's still some activity going on ... we'd like to know what your thoughts are and what can we continue to do to keep patrons safe

The matter was discussed at length with input from all present with the Board with Mr. Mallowes stating that he's seen a significant difference by having the Police Detail and that they enjoy having them; adding that they have not had any issues inside and that most issues arise when they deny entrance of patrons into the establishment for different reasons and at closing time when people are exiting the premises at the end of the night.

When asked by Chairman Beauregard if they've seen a change in the type of clientele that they are attracting, Mr. Mallowes responded, at one point last year it was getting a little rough ... but we've put a cover in place ... we pat down every single person that is allowed in ... I'm not too concerned about the type of clientele we're attracting ... it's the same type of music everyone else is playing downtown right now ... it's just that we have a bigger place ... so there are more people to watch ... but we have 8 guys inside every night ... plus the two police details ... I feel strongly that we do a good job of managing it.

Capt. Sousa just voiced his concern of what's occurring at the end of the night when the crowds are being pushed onto the street and that they tend to congregate in the area.

Mr. Mallowes stated a lot of people are waiting for cabs or Ubers and asked if there was any way the city could create a Cab or Uber waiting area in which people could wait for their rides, to which Chairman Beauregard responded, that would be something you have to discuss with the Mayor's Office or the Traffic Commission.

When asked by Capt. Sousa if UMass was still busing kids into the downtown area, Mr. Mallowes responded, we really don't get a big UMass crowd and those that come into the downtown area usually Uber in.

Chairman Beauregard responded to what was presented by stating, you have a very good success record behind you ... it's a little different neighborhood from which you're coming from (to which, Mr. Chitas agreed) ... so you have to be mindful of that... from where you were at to where you're going ... it's been a little bit of a hotspot lately ... and to Mike's credit ... he's Done a pretty good job of keeping it clean ... so we're just giving you forewarning as to what you need to be aware of. When asked by Chairman Beauregard if his staff would be T.I.P.S Certified, Mr. Chitas responded, "absolutely".

Responding to questions from Chairman Beauregard, Ms. Ruvich stated, we are going to be relocating our restaurant up the road ... as a result of having some issues with our current location ... it's just not conducive to running our business there any longer, so we're making the move to 768 Purchase Street ... our goal is to do basically what we're doing now.

When asked by Chairman Beauregard if they're currently open till 2 a.m., Ms. Ruvich responded, we're currently open until 10 p.m. ... we're going to try to stay open a little bit later ... maybe 11 p.m. or midnight ... we'll sort of play around with it ... and see how late night food goes at this location.

Chairman Beauregard responded by stating, as you probably heard in the previous hearing, you're now in a different location than you were before ... the clientele late night will be a little different than you were dealing with at your other location.

Ms. Ruvich responded it's going to be a different world I think ... we're curious ... but we're not looking for the riff raft ... so we'll close before the riff raft comes around ... we're not looking to be a bar ... we still want to be a restaurant.

Chairman Beauregard responded, that's exactly my point ... where you are now is a little out of the way from where you are going ... now you are going to be right in the middle of those places that stay open later ... Greasy Luck ... No Problemo ... Poor Farm ... so you got to make sure you're not adding to the late-night problems.

When asked by Chairman Beauregard if there were going to be any other changes such as adding entertainment, Ms. Ruvich responded, no... just the added outdoor seating in front of the building and on the rear deck area hanging onto Wing's Court. When asked by Mr. Nanopoulos when she is anticipating moving to the new location, Ms. Ruvich stated, its' a delicate balance ... so we're going to try to be moved completely by February 1st ... the sooner the better though ... but that all depends when we get our approval notice ... so we're kind of preparing ourselves for the worst ... and hope for the best ... so we'll probably continue to operate ... then be down for a week for the move.

Mr. Nanopoulos informed Ms. Ruvich that the 2020 Liquor license and her other licenses would be issued for the current location (22 Elm Street) and that when the approval comes through the current licenses would have to be surrendered and new licenses would be issued for 768 Purchase Street; adding, that they could not serve alcohol at the new location until the approval from the ABCC is received and the new license is issued.

<u>Present:</u> Atty. John Ruggeri along with Jacinta Murphy, Owner and Proposed Manager; and Peter Andrade, Building Manager and Jim Murphy

Responding to questions from Chairman Beauregard, Atty. Ruggeri responded on behalf of his client, I represent Ms. Murphy who bought the Kilburn Mill building back in June of 2017 ... she is now looking to establish a business on the premises ... the Kilburn Event Center ... which is the d/b/a for the Kilburn Hospitality Group, LLC. ... which she intends to operate in the 13, 000 sq. ft. area that is shown in the plans on the 3rd floor of the building ... she's prepared to answer any questions the Board may have for her regarding this endeavor ... adding that he wanted to thank Mr. Nanopoulos for all his assistance as well as to the other city departments that have helped up to this point in getting us to this position in the process.

Chairman Beauregard then asked Ms. Murphy to inform the Board as to what her intentions are going forward for this rather large space, to which Ms. Murphy responded, we want to occupy a 13,350 sq. ft. area on the 3^{rd} floor of the mill ... which includes a locked 8 'X 10' liquor storage space ... so basically it will a place where we can have events ... and weddings ... and things like that.

Atty. Ruggeri added, the event center has been operating ... and has had several events there, up until this point ... but without a liquor license ... they've applied for one-day licenses ... and they've have had to bring in outside vendors to provide the alcohol ... their hope is that through this process that they can reap those benefits of selling and serving the alcohol themselves at the events they host ... so that she can continue to remodel the building to improve the building for the betterment of the South End in general.

Chairman Beauregard responded, so you're going to be providing your own alcohol ... no more outside vendors ... your own staff and servers ... so the way it's been operating it's not going be operating moving forward once you're approved ... you understand that, to which Ms. Murphy responded, that's correct!

Chairman Beauregard reiterated his last comments, you're purchasing and serving all the alcohol that will be served by your own staff, to which Ms. Murphy responded, that's correct! ... in fact, we're in the process of interviewing a professional experienced manager ... so we've interviewed some local people ... so I'm a registered nurse by trade ... I have an extensive management background ... I currently oversee a staff of 60 people ... so with said ,,, safety is paramount ... and attention to detail is important to me ... so I would say that would be the same to me in holding such an important thing as a liquor license ... so it's truly important that we have the right people in place.

To which Chairman Beauregard responded, I can't say enough about my concerns regarding safety issues because it's such a large space ... you're on the 3rd floor of an old mill building ... and if something was to happen ... it will take the Police and Fire a while to get in there to determine what's going on with everybody running out of the building ... and them entering the building ... so we don't want to see that happen .. so it's paramount that you find the right manager and staff to oversee this operation ... and to be mindful of the clientele that you are catering too ... you heard me earlier raise the same concerns with Greasy Luck who also has a large hall ... and that's not nearly as big as yours ... sometimes we're not on the same page with the management as where we would like to see it to be ... and as I said previously ... you're on 3rd floor ... three flights of stairs ... and these guys (Police & Fire) running in not knowing what they're running into is a concern for this Board ... so it would behoove you to find the best management you can to be able to oversee that environment ... and make sure whoever you're hiring is T.I.P.S. Certified and is trained in crowd control as well as in other safety measures ... and be cognizant of the types of events you're catering too ... it behooves you to do your do diligence when you're booking an event ... you'll have people come in and tell you it's what type of event ... then the night of the event ... it may be something completely different ...they may tell you it's a 30 year old birthday party ... then the next thing you know ...it's a "Sweet Sixteen Party" with 400 kids in the place ... which are not allowed ... so you need to have some type of contract forms that should be filled out with all the pertinent information as to who's renting the facility ... what type of event is it ... security measures ... so you know exactly what's going on ... which will help you with the liability on your part ... to show that you asked the pertinent questions and they signed here ... and have contact information for the police to use, if need be ... we've seen it.

Atty. Ruggeri responded to Chairman Beauregard by stating, I can speak to that a little bit ... the event center does have a space rental contract with people ... so we do know who's coming in ... we do know what they will be doing ... and we've followed all the recommendations put forth by all city departments with regard to safety ... whether it be Fire ... Police ... Building ... Health ... or your Board ... there are no issues with that ... we want to run a clean shop ... a great shop ... and everybody has to be safe ... and we're mindful of things that can happen.

When asked by Chairman Beauregard as to what they would be doing regarding the service of food, Ms. Murphy stated they would be using caterers

Atty. Ruggeri also responded by stating, at the present time ... there are no cooking facilities on the premises ... that will probably change ... we would have to apply for any licenses or permits for that at the appropriate time ... right now... all food will be catered by license caterers coming into the facility ... which we have done up to this point.

After being recognized by Chairman Beauregard, Mr. Nanopoulos responded to a question that was poised to him earlier in the day regarding someone who wanted to rent the space but wanted to bring their own alcohol onto the premises; Mr. Nanopoulos informed those present that it was against the law to bring alcohol onto a licensed premise and that all alcohol must be purchased through a licensed Wholesaler or Importer and/or Farmer-Winery or Farmer-Brewery; a copy of the regulation was also handed to the proposed licensee and her Attorney.

When asked by Mr. Nanopoulos if the person they find to be the general manager would be named as the manager of the liquor license, both Atty. Ruggeri and Ms. Murphy stated that an application would be submitted naming that person as manager of the liquor license and the person responsible for the day to day operation of the event center; and the person responsible for renting out the event center.

Mr. Nanopoulos suggested that he be allowed to send to the licensee, a copy of the rental agreement form that the Board issues from time to time, so that the licensee ensures that all pertinent information the Board would be looking for regarding an event is gathered.

Atty. Ruggeri welcomed the idea and stated that they would incorporate any additional information the board would require into their existing agreement form.
