PUBLIC HEARING

PH1.

John Souza, Kevin Mendoza, 42 Brown Street is requesting to install three curb cuts at 101 Belleville Ave one 11' x 8' curb cut on Cotter Street, one 22' x 8' on Cedar Grove Street and one 18' x 3.7' on Belleville Ave and also remove 51' of existing curb cut on Belleville Ave (Plot 85, Lot 300)

Commissioner Silva motioned to open PH1; second by Commissioner Markey the Ayes have it.

Jim Bernandino of Bohler Engineering states the proposal is to construct a new Dunkin Donuts facility it will be a complete raise and rebuild to allow for the construction of new Dunkin Donuts. Jim Bernandino states he is front of the Traffic Commission for approval for three curb cuts, 22ft on Cedar Grove which is a full two way access, 18ft wide on Belleville which will be an entrance only and 11ft cut off of Cotter Street which will be exit only to allow for traffic that doesn't want to go through the drive thru. There is an existing curb cut along Cedar Grove Street that will be modified and relocated to accompany the new development. Chairman Liberty asked any questions for the petitioner. Commissioner Silva states to modify the petition that the curb for Belleville Ave should read 18' x 9'.
