1. PETITION

Christina Connelly and Laurie Alfonso, on behalf of the Administration, are proposing to create three parking zones within the Downtown Transportation Facilities as set forth in the New Bedford Code of Ordinances, Section 23-48-1 in accord with the Traffic Commission's authority pursuant to Sections 23-30, 32,35 and 37 of the Code. These zones will be differentiated by time limits and meter rates; this petition seeks approval of the zones, associated time limits and meter rates. (Map of zones and time limits is on file).

Commissioner Gomes motioned to table P1, second by Commissioner Baker; the Ayes have it.

3. PETITION

Chairman Liberty asked if anyone had any questions, Commissioner Silva suggested that we should have no parking on that whole north side. Commissioner Silva motioned to amend P3 to have no parking on this side

of the street on the north side of Coffin Ave between Brook Street and Church Street. Chairman Liberty asked if anyone would like to speak in favor or anyone would like to speak in opposition. Commissioner Silva motioned to approve P3 as amended, second by Commissioner Gomes; the Aves have it.

4. PETITION

Councillor Gomes and Councillor Hugh Dunn are requesting **FOUR WAY STOP** signs at Logan Street and Acushnet Ave; currently there are stop signs on Acushnet Ave. (Angular Accident Report 2017=6 April, May, June, July, October, November, 2018=1 April, 2019=May)

Councillor Dunn stated that about a year ago he came looking to turn this intersection into a four way stop, he states that it didn't get approved last year so in the meantime we switch the stop signs and in theory that could help but people are not use to that and it has called more confusion. Chairman Liberty asked if there were any questions for the petitioner. Commissioner Simmons asked if there were any bushes or trees that block the view. Councillor Dunn stated there is a fence but there are no stop signs on Acushnet Ave so there is a lot of speeding. Commissioner Gomes stated he has spent time there and its horrendous, they are no coming off Purchase Street east on Logan and picking up speed and when they get to the overpass you can not see what is coming at you. Commissioner Gomes also asked for crosswalks to also be installed there as well. Chairman Liberty asked if anyone would like to speak in favor or in opposition. Commissioner Gomes motioned to amend with crosswalks installed, second by Commissioner Baker; the Ayes have it.

Chairman Liberty asked if there were any questions for the petitioner. Commissioner Silva asked if this new drop zone was between the new driveway and the corner. Chairman Liberty asked if anyone would like to speak in favor. Jane Gonsalves, 2 Clinton Place long time board member of the YMCA spoke in favor of P5. Chairman Liberty if there was anyone else who wanted to speak in favor or opposition. Commissioner Gomes suggested that we just go 8am-4pm and not have the time in between that way we don't have to worry about anyone parking there. Commissioner Gomes amended the petition to change the timeframe from 8am-4pm Mon-Fri. Commissioner Gomes motioned to approve as amended, second by Commissioner Simmons; the Ayes have it.
