Councillor Gomes called the Appointments & Briefings Committee Meeting to order and took attendance. Councillor Gomes asked that the Committee stand for a Moment of Silence of the passing of Councillor Coelho's mother. The Clerk read Communications from Councillors Bousquet, Coelho and Rebeiro explaining their absences. These Communications were received and placed on file by Councillor Abreu and seconded by Councillor Winterson.

Notice, City Clerk of reference of a Public Hearing, on APPLICATION, Imad Saker, for a SPECIAL PERMIT for Motor Vehicle Sales and Rentals at 384 Dartmouth Street, New Bedford, MA 02740 (Duly advertised in The Standard-Times on Wednesday, November 30, 2016 and Wednesday, December 7, 2016) (Ref'd 11/15/16) was received and placed on file and the hearing opened by Councillor Morad and seconded by Councillor Carney. Imad Saker, 25 Donald Street, Dartmouth, Ma, gave an overview of his business. He is buying the old Capitol Motors property on Dartmouth Street in New Bedford. He as over twenty-five years of experience in car sales, the last five was for a business in Norwood Ma. He has decided to go into business for himself. He will be doing just sales for now, no rentals at this time. There will also be no repairs done on the property. He will have at least twenty-five (25) vehicles on the lot, there will be no vehicles parked on the street.

The Chair asked if there was anyone who would like to speak in favor of the Special Permit, there were two, as follows:

Bernadette Silva, 106 Sagamore Street, told the Committee that she did not object to the business but was just concerned about the lots lighting shining into her bedroom window and the hours of operation.

Mr. Saker assured the lighting would shine away from the home and the hours of operation would be 8 a.m. to 6 p.m.

Beverly Souza, 388 Dartmouth Street, did not object to the business but was concerned about the twenty-five cars listed on the petition.

Commissioner Romanowicz was present to answer questions. He stated that the plan presented can accommodate the twenty-five vehicles. The only outstanding issue was the MDC trap, which the building did not have one, so the owner would not be able to do repairs on the property. Mr. Saker understood this.

The Chair asked if there was anyone who wished to be recorded in favor of the Special Permit, there was none. He then asked if there was anyone who wished to speak in opposition of the Special Permit, there was none. Imad Saker, 25 Donald Street, Dartmouth, MA, was present and addressed the Committee. He explained he would run his business in conjunction with his Auto Sales business just approved by the Committee in the previous matter.

Mr. Saker told the Committee that the livery cars would not increase the number of vehicles for sale on his lot; it will stay at twenty-five. He will be doing mostly non-medical transportation to the Boston area. He is going to start out with two vans.

They primarily do airport runs and medical appointment runs and they are looking to expand to New Bedford. They were approached by GATRA to see if they had an interest in expanding to New Bedford and decided it would be a good step for their company. The drivers use company vehicles which stay with them. All the cars go home with their employees and they are vehicles not vans. The clients call them to secure services. All drivers are vetted and go through the CORI process. They will do the same for New Bedford employees. They hope to start with three drivers and expand to ten by the end of 2017.
