Councillor Alves called the Appointments & Briefings Committee Meeting to order and took attendance. Communications were read into the record for Councillors Gomes, Lopes and Oliveira stating their reasons for not attending this meeting. These communications were received and placed on file by Councillor Bousquet and seconded by Councillor Carney.

Notice, City Clerk of reference of a Communication, City Clerk/Clerk of the City Council, to City Council on behalf of **Jenny Mejia d/b/a JENNY'S TRANSPORTATION**, **88 Sagamore Street, New Bedford, MA 02740** hereby submit a copy of the Application requesting a <u>NEW Private Livery License</u>, under the provisions of M.G.L. Chapter 159A, Section 1 and amendments thereto, and M.G.L. Chapter 270, Section 22 (Smoke Free Workplace Law) and all other laws applicable to such operation, to carry passengers for hire over the streets of New Bedford (Ref'd 11/24/15) was received and placed on file by Councillor Morad and seconded by Councillor Martins. Ms .Jenny Mejia introduced herself to the Committee and Councillor Morad asked her to tell them about her Livery Business. Ms. Mejia explained that she would like to start a business with two minivans, which she has not yet purchased, to bring children to and from school (from their homes). She explained that she has offstreet parking in her home's driveway for the vans. It would be herself and one other employee doing the driving.

On motion by Councillor Morad and seconded by Councillor Bousquet, the Committee VOTED; To recommend to the City Council APPROVAL, of the Application of **Jenny Mejia d/b/a JENNY'S TRANSPORTATION**, **88 Sagamore Street**, **New Bedford**, **MA 02740**, for a <u>NEW Private Livery License</u>, under the provisions of M.G.L. Chapter 159A, Section 1 and amendments thereto, and M.G.L. Mary Rapoza, Director of Recreation and Beaches, informed the Committee that all parks have the "Close at Sundown" policy and that rule would also apply to the Harbor Walk, even though it is not designated as a park, nor is it under her department's jurisdiction. She was unsure if a sign is currently in place stating that the walk closes at sundown.

On motion by Councillor Morad and seconded by Councillor Bousquet, the Committee VOTED: To table this matter at this time. This motion passed on a Roll Call Vote of Yeas 7, Nays 1, Councillor Martins opposed
