## RESOLUTION IN RECOGNITION AND CELEBRATION OF NATIONAL WOMEN'S HISTORY MONTH - MARCH 2015

WHEREAS, American women of every race, class and ethnic background have made historic contributions to the growth and strength of our Nation in countless recorded and unrecorded ways and have served as early leaders in the forefront of every major progressive social change movement in the United States; and

WHEREAS, American women have played and continue to play a critical economic, cultural and social role in every sphere of the life of the Nation by constituting a significant portion of the labor force working inside and outside of the home; and

WHEREAS, Founded in 1980, the National Women's History Project, is a non-profit educational organization committed to recognizing and celebrating the diverse and significant historical accomplishments of women by providing

information and educational materials and programs and led the drive to write women back into history by recognizing the achievements of women in all facets of life; and

WHEREAS, The THEME for 2015, and the Thirty-fifth Anniversary Celebration is "WEAVING THE STORIES OF WOMEN'S LIVES", honors the lives of individual women, revealing the choices they have made, encouraging girls and young women to think larger and bolder and also gives boys and men a better understanding of the female experience, challenging stereotypes and assumptions about who women are and what they can accomplish today, also remembering and honoring our ancestors' sacrifices and commitments, we celebrate the many ways that women's accomplishments have become woven into the fabric of our National story; and

WHEREAS, When women sought to question inequalities in their own lives, they turned to history to understand that if a woman's role could be socially constructed within a specific historical context, rather than natural and universal, then women could argue that it was open to change; and

**WHEREAS,** American women have played a unique role throughout the history of the Nation by providing the majority of the volunteer labor force of the Nation and American women were particularly important in the establishment of early charitable, philanthropic and cultural institutions in the United States; and

**WHEREAS,** American women have been leaders, not only in securing their own rights of suffrage and equal opportunity, but also in the abolitionist movement, the emancipation movement, the industrial labor movement, the civil rights movement and other movements, especially the peace movement, which created a more fair and just society for all; and

**WHEREAS,** Women's history is now far more embedded in the curriculum of higher education than half a century ago, the number of professors in women's history has increased and it remains important to promote research into women's history both inside academia and in the wider community; and

**WHEREAS,** Despite these contributions, the role of American women in history has been consistently overlooked and undervalued, in the literature, teaching and study of American History:

**NOW, THEREFORE, BE IT RESOLVED,** That the New Bedford City Council hereby recognizes March as **NATIONAL WOMEN'S HISTORY MONTH,** thanks all the women locally and Nationally who have made a mark on our City, State and Country's culture, government and society in general.
