RESOLUTION HONORING CHRISTOPHER J. DUMONT, MASSACHUSETTS STATE TROOPER AND FORMER NEW BEDFORD POLICE OFFICER FOR BEING SELECTED AS THE 2014 NATIONAL TROOPER OF THE YEAR

WHEREAS, Massachusetts State Trooper Christopher J. Dumont, was raised in New Bedford, Massachusetts, is the son of Donald and Pauline Dumont, husband of Kerrie Maciejewski Dumont, and father of their three young children, Addison, Reese and Roxie; and

WHEREAS, Trooper Dumont graduated from Bishop Stang High School in 1995 and received his Bachelor of Science Degree in Criminal Justice from Northeastern University in 2000, he was a New Bedford Police Officer for six years before joining the State Police in 2005, and is currently assigned as a Homicide Investigator in the State Police Detective Unit in the Bristol County District Attorney's Office, New Bedford, Massachusetts; and

WHEREAS, Trooper Dumont was recognized by the New Bedford City Council in June 2013 for his courageous actions during the aftermath of the Boston Marathon Bombing, where Trooper Dumont along with those of his fellow law enforcement brothers, led to the apprehension of the two suspects responsible for the Boston Marathon Bombings and the saving of the life of a fellow Officer; and

WHEREAS, Massachusetts State Trooper Dumont, an Advanced Certified Paramedic, played a major role in saving the life of MBTA Officer Richard H. Donohue, Jr., who was shot during the gun battle in Watertown with the two Boston Marathon Bombing suspects, taking charge of the care of the wounded Officer, risking his own life to provide medical care to Officer Donohue during the ongoing gun battle with Police in a very volatile situation; and

WHEREAS, Although Trooper Dumont has continually downplayed his role in the events of the early morning hours of Friday, April 19, 2013, he has been recognized and honored by many Federal and State Agencies for his heroic actions in the aftermath of the Boston Marathon Bombings; and

WHEREAS, The most recent recognition of Trooper Dumont was his selection as one of twenty- five Massachusetts State, Boston and Watertown Police Officers, honored with the "Top Cops Award" during National Law Enforcement Week, where Trooper Dumont and the other Top Cop Award recipients met with President Barack Obama and Vice-President Joe Biden and while in Washington being further honored by having a horse named for Trooper Dumont and donated to the United States Park Service by Horses and Heroes; and

WHEREAS, In May 2014, once again Trooper Dumont was recognized, this time by his peers of the American Association of State Troopers, who annually select one State Trooper from across the County and named New Bedford native, Trooper Christopher Dumont as the 2014 Trooper Of The Year, stating that "Trooper Dumont's actions during the chaos and shootout aftermath of the Boston Marathon Bombings represented all State Troopers in his professional response, that his heroic and life-saving actions, and the humble manner in which he has handled the aftermath truly represent the characteristics that all Officers can only hope to emulate.":

NOW, THEREFORE, BE IT RESOLVED, That the New Bedford City Council hereby once again honors CHRISTOPHER J. DUMONT MASSACHUSETTS STATE TROOPER AND FORMER NEW BEDFORD POLICE OFFICER, for his courageous actions during the aftermath of the Boston Marathon Bombing, congratulates him on being selected by The American Association of State Troopers as the 2014 Trooper of the Year, the one Officer in the County to receive this prestigious honor, thanks him for his dedication to his profession and wishes him continued future success.

CITY OF NEW BEDFORD IN CITY COUNCIL JULY 17, 2014 RESOLUTION HONORING THE 100TH FEAST OF THE BLESSED SACRAMENT NEW BEDFORD, MASSACHUSETTS

WHEREAS, The one hundredth Feast of the Blessed Sacrament commences Thursday, July 31, 2014, in New Bedford, Massachusetts, a four day mid-summer traditional "*Festa*" the oldest and largest Portuguese Feast in North America; and

WHEREAS, Since its beginning in 1915, The Feast of the Blessed Sacrament has celebrated the rich culture of the Portuguese people, in particular the heritage of the people from the Island of Madeira, a Portuguese island off the coast of Morocco; and

WHEREAS, A committee of four Madeiran immigrants called *Festeiros* initiated the *Festa* at Our Lady of the Immaculate Conception Church during the first weekend in August 1915, the founders were Manuel Agrela, Manuel Agrela Coutinho, Manuel Santana Duarte, from the Village of Estreito da Calheta and Manuel Gomes Sabastiao from the Village of Prazeres; and

WHEREAS, From 1915 through 1945, The Feast of the Blessed Sacrament reflected Old World Portuguese customs, an abundance of street decorations, brass bands, fireworks, Portuguese food was sold from *barracas* managed by the *Festeiros* and their families, Madeira wine served from authentic casks direct from

the Island and most importantly, devotional services were conducted in the Church with a formal Procession honoring the Blessed Sacrament through the neighborhood streets; and

WHEREAS, For thirty years, The Feast of the Blessed Sacrament emphasized Madeiran music, dancing and costumes and strict membership requirements for the *Festeiros* who comprised the committee, only Madeiran born adults males or their male descents were allowed on the committee, Old World customs and the religious importance of the *Festa* were kept, and as the decades passed and crowds grew, the Feast Committee expanded its membership; and

WHEREAS, After the Second World War the size of the committees grew, and many of the new members were American born sons of immigrants and this difference affected the *Festa*, the parade in post-war New Bedford took on an understandably patriotic tone, with Veteran groups, floats, political figures, military color guards and beauty queens; and

WHEREAS, In 1951, The Feast of the Blessed Sacrament had become so large that the Club Madeirense S. S. Sacramento was formed and incorporated in 1953, with membership open to all former *Festeiros*, the goal being to promote and expand the Feast, the Club invested in a piece of private property giving the Feast of the Blessed Sacrament and the Club a permanent home for the future; and

WHEREAS, In 1954, the *Festeiros* called their new property Madeira Field, and the Club Madeirense S. S. Sacramento, Inc., was responsible for the maintenance of half a City block, the Feast Committees continues to offer money or material gifts to the Club Madeirense S. S. Sacramento, Inc., after donations to the Church and charities are made, the Club uses these funds to maintain and improve the Feast grounds; and

WHEREAS, In the decades that followed, the Feast of the Blessed Sacrament underwent major modernization due to second and third generation Madeiran-Americans born and raised in New Bedford, who saw the *Festa* as a religious and ethnic event; and

WHEREAS, On July 31, 2014, the *Festeiros*, led by the Feast President will march in a special procession to Our Lady of the Immaculate Conception Church where a Special Benediction to the Blessed Sacrament is held, a Blessing is bestowed upon the *Festeiros* and the Club Madeirense S. S. Sacramento, Inc., where upon, the *Festeiros* march to the Madeira Field, where as they do every year, they pay tribute to the four original *Festeiros* who founded the *Festa* and then, they will officially open the One Hundredth Feast of the Blessed Sacrament:

NOW THEREFORE, BE IT RESOLVED, that the New Bedford City Council hereby honors the ONE HUNDREDTH FEAST OF THE BLESSED SACRAMENT, remembers with gratitude the four founding *Festeiros*, and all *Festeiros* and volunteers throughout the last century who, in tribute to their Madeiran Heritage and their devotion to the Blessed Sacrament have given their time and energy to the *Festa*, thanks them for their hard work and wishes them many years of continued success.

RESOLUTION HONORING THE OAKS NURSING AND REHABILITATION CENTER ON THE COMMEMORATION OF THE CENTER'S 25TH ANNIVERSARY CELEBRATION AND AWARDS CEREMONY

WHEREAS, The Oaks Nursing and Rehabilitation Center is a 122-bed Skilled Nursing Facility, located in the far north end of Historic New Bedford, providing medical management, rehabilitative care and long-term residential care to local area adults; and

and

WHEREAS, The Oaks Nursing and Rehabilitation Center admitted the first patient on July 10, 1989;

WHEREAS, Upon opening, the facility employed approximately fifty employees, some of whom are being honored tonight with twenty-five year service awards, who worked diligently to staff and supply the facility's basic operating needs in the first year of operation; and
