Councillor Alves called the Appointments & Briefings Meeting to order and took attendance. The Clerk read into the record, a Communication from Councillor Morad stating she would not be in attendance due to her chaperoning the Winslow Elementary School Children to the PawSox game. This Communication was received and placed on file by Councillor Lopes and seconded by Councillor Carney. Councillor Gomes called in stating he was feeling ill and would not be in attendance.

Notice, City Clerk of reference of a PUBLIC HEARING, on a Communication/Demolition, New Bedford Historical Commission, to City Council, re: BUILDING DEMOLITION REVIEW, 177 Cove Street, MAP 20, PARCEL 346, advising that "built in 1915, the structure is a two and one-half story hipped roof building originally covered with clapboards, the most visually important aspect of the building is the full height columned entry which originally had a first and second story porch with balustrades; constructed as the Charron Maternity Hospital in the Neo- Classical style, the building was designed by the well-known local Architect Louis E. Destremps and constructed by local builder Napoleon Lapointe, both members of the French Canadian Community; currently rented and occupied as a half-way house, the building is structurally sound and until a few years ago operated as a funeral parlor, the first and second story porches have been removed and all the original windows have been replaced; the original garage has been removed and all the original shape and massing; the subject structure is found to be historically significant for its connections to the French Canadian Community and as a local example of Neo-Classical style architecture as designed by local Architect Louis E. Destremps"; and therefore, "the NBHC has determined that 177 Cove Street is a historically significant

structure and preferably preserved" (Ref'd 2/13/14, advertised in the Standard-Times on Wednesday, April 9, 2014) was received and placed on file by Councillor Coelho and seconded by Councillor Lopes. The Chair opened the Hearing. (1)

Mrs. Diane Henry, Chair of the New Bedford Historical Commission spoke in favor of the delay in the hopes that the building can be saved.

The Chair asked if anyone wanted to speak in favor of delaying the demolition, they were as follows:

Jessica De Costa of 608 South Second Street, Gerard Bourassa of 148 Bryant Lane and Donna Downing of 616 South Second Street.

No one wished to be recorded in favor.

The Chair asked if anyone wished to speak in opposition to the six month delay in this demolition, they were as follows:

Mr. Michael Panagakos, owner and developer of the property, stated that all the 6 month delay will do is simply delay the inevitable: that the building will in fact come down. He explained that the building has been for sale for several years, it has had several fires, there is barely anything original on or in the building. He stated that the current tenants are being evicted and are expected to be out by May 13th, at which time the property will be boarded up.

Councillor Bousquet asked Mr. Panagakos what his plan for the property is. Mr. Panagakos stated that he will develop a small retail location there, which will look nice, be built well and add to the area.

Councillor Coelho stated that, having heard from the public tonight, she hopes that Mr. Panagakos would save the building and not tear it down. Mr. Panagakos replied that a few people showing up to a meeting and asking that the building not be demolished does not, in his opinion, qualify as "hearing from the public" as Councillor Coelho suggested. He re-stated that the building has been for sale for several years and no one else wanted it. He is going to do something good with the property that is also beneficial to the city and the neighborhood.

Councillors Coelho and Rebeiro both strongly urged Mr. Panagakos to reconsider demolishing the building and instead try to find a way to keep the structure up. Mr. Panagakos, once again, reiterated his position that there is barely anything original left in the building and has no historical value. He also stated that he will in fact demolish it after the delay, if that is what is decided upon. Councillor Coelho stated to Mr. Panagakos that he should save the building because he can afford to do so.

No one was recorded in opposition to the delay. The Chair closed the hearing.

Councillor Martins asked to hear from Ann Louro, the Preservation Planner. Ms. Louro stated that she too is hoping for the delay in the hopes that some other plan for the building can be developed

and put into action rather than simply demolishing it. Councillor Martins asked if the Historical Commission would actively search for a potential buyer. Ms. Louro replied that the Historical Commission does not normally get involved in that manner, but perhaps they could do so.

On motion by Councillor Lopes and seconded by Councillor Coelho, the Committee VOTED: To recommend to the City Council, a six (6) month delay on the Demolition of 177 Cove Street, Map 20, Parcel 346. This motion passed on a Roll Call vote of Yeas 8, Nays 1, with Councillor Alves opposed.

Councillor Lopes asked that item 6 and 6a be taken out of order. There were no objections.

Notice, City Clerk of reference of a Written Motion, Councillor Rebeiro, requesting that the Committee on Appointments and Briefings discuss and accept the petitions signed by New Bedford Residents regarding the retirement of Emily & Ruth from the Buttonwood Zoo to an elephant sanctuary (Ref'd 1/9/14) and a Communication, Councillor Morad, submitting letter received on March 17, 2014, by Theresa W. Kim, M.D., to City Council, relative to moving the elephants, Emily and Ruth to an elephant sanctuary in Tennessee (Ref'd 3/27/14) were received and placed on file by Councillor Martins and seconded by Councillor Lopes. (6, 6a)

Ms. Joyce Rowley of 49 Orchard Street addressed the Committee asking that the Council consider sending the Zoo's elephants to the Elephant Sanctuary in Tennessee. Chantel Pavao of 2 Shaw Street also spoke in favor, as did her sister Corrine Pavao of the same address. Dr. Theresa Kim of 99 South Street, Roslindale, MA also spoke in favor of moving the elephants, saying that it is what they deserve. However, for the record, Councillor Lopes asked her if she was a Veterinarian or an Elephant Specialist; she said she is neither.

Ms. Rowley presented the Committee with a video presentation of the sanctuary and reasons why, in her opinion, the elephants needed to be moved out of the Zoo.

Councillor Rebeiro asked if it is true that elephants in sanctuaries and/or natural habitats live longer than those in Zoos. Ms. Rowley said that her research stated that they do. She also stated that because there is not enough space for Ruth and Emily, Ruth will absolutely be attacked by Emily again. She criticized the Zoo Staff, stating that they have "lost" several animals over the years.

Councillor Rebeiro stated that perhaps it is time for people to stop thinking of the elephants as there for personal entertainment and begin seeing them for living things that deserve better treatment. She too criticized some of the practices at the Zoo.

Councillor Martins asked Councillor Rebeiro if she had ever been to the Zoo or had spoken with the Zoo Staff or its Director. Councillor Rebeiro admitted that she had not as of yet, but is planning a visit there soon. However, she added, her research about elephants has led her to agree with Ms. Rowley that the elephants are being mistreated at the Zoo and should be moved to the sanctuary rather than being held on to for Zoo profits. Keith Lovett, Zoo Director also addressed the Committee. He stated that the Buttonwood Park Zoo was just recognized by the AZA Accreditation as one of the best Zoos in America, and that this is the third time it has received such recognition. He stated that the Tennessee Sanctuary does do good work, but he also pointed out several problems/issues that it has had over the years, and is currently having. These problems include the fact that there have been three (3) Executive Directors since 2011, and the current one is not an elephant expert, it does not currently have a Director of Elephant Care, and that the Veterinarian on staff recently left. In fact, the sanctuary was recently cited as having staff that lacked experience and knowledge. He stressed that the Zoo does not "make money" off of the elephants, but conversely is actually losing money on them. However, he feels that because it is the best place for Ruth and Emily to be, that the Zoo is spending the money to keep them here.

On motion by Councillor Lopes and seconded by Coelho, the Committee VOTED: To take "No Further Action" on this matter at this time. This motion passed on a voice vote.

Notice, City Clerk of reference of a Written Motion, Councillor Alves, requesting, that the Committee on Appointments and Briefings meet with representatives of Community Choice Aggregation to discuss implementing a municipal aggregation program in the City of New Bedford similar to the program being considered by the City of Brockton; and further, that members of the Brockton City Council be invited to share their input and outline the beneficial opportunity for our residents and businesses in the City (Ref'd 2/13/14) was received and placed on file by Councillor Martins and seconded by Councillor Coelho. Mr. Leo Sullivan with Global Technology addressed the Committee. He presented them with a Power Point presentation about Community Choice Aggregation, which would enable New Bedford and other cities, and their residents and businesses, to join forces in buying and providing energy for a greatly reduced rate. The benefits of such a program would include:

A minimum of 7% savings on both business and residential rates for electricity An increased percentage of green power to New Bedford Attracts new business to the city due to lower energy rates

He stated that Brockton is very interested in doing this with New Bedford and potentially Fall River. He explained that there are currently five states that allow this, which are Massachusetts, New Jersey, Ohio, Illinois and California.

Critical to the program's success are:

Web-Site Newspaper Ads Direct Mail Phone Hotline Press Kits Public Education He explained that NSTAR would still bill the consumers, and that the only change – in addition to the reduced rate - would be WHO supplied the energy.

Councillor Oliveira asked Mr. Sullivan if Global was the only company that does this. Mr. Sullivan stated that they are not, and that it is, in fact, a competitive market.

On motion by Councillor Oliveira and seconded by Councillor Lopes, the Committee VOTED: To recommend to the City Council APPROVAL of the opportunity to entertain Community Choice Aggregation Program with the recommendation that the Mayor consider utilizing Global as an information expert on this matter. This motion passed on a voice vote.
