MAYOR'S PAPERS

REVISED ACT, relating to the Harbormaster of the City of New Bedford, the proposed Act authorizes the Mayor with the approval of the City Council to appoint a Harbormaster, who shall be a resident and registered voter of the City, unless a Residency Waiver is requested by the Mayor and approved by the City Council, said appointment shall be for a term of not more than five years.

Woolworth Company store with a decorative terra cotta façade, the front façade is bent to follow the street alignment and the bend serves to divide the building into two nearly equal sections, stepped parapets are spaced along the roof line, one in the center of the wide Woolworth's store front, which contains two recessed entries, and two others above the entries into the subsidiary store fronts, an Art Deco-style cast stone frieze decorates the roof line; as the only surviving national chain store located on Acushnet Avenue, the building is architecturally and historically significant in the context of the mid-20th Century commercial development of the North End business district and its abandoned and altered condition diminishes its individual significance; however it is an important contributing component of a potential Acushnet Avenue historic district" and therefore, "the NBHC has determined that 1131-1145 Acushnet Avenue is a historically significant structure and preferably preserved."

COMMUNICATION/DEMOLITION, New Bedford Historical Commission, to City Council, re: BUILDING DEMOLITION REVIEW, 460 SOUTH FRONT STREET, MAP 25A, PARCEL 10, advising that" a circa 1882 office building constructed for the Acushnet Mills Corporation, this one-story brick structure has a painted façade and flat roof, evidence of the Italianate style presents itself in the deep cornice with decorative brackets as well as the segmented arch window opening; the structure once had a partial second story (now removed) and has had several structural additions; the structure is in poor condition because of fire damage and its interior is completely gutted, the building is vacant with its windows and entries boarded with plywood; organized in 1882 the Acushnet Avenue Mills Corporation manufactured cotton cloth and by 1889 employed about 1,000 operatives and provided rental tenement housing to its workers on Front and Blackmer Streets, the mill buildings were demolished in the early 1950's much of the affiliated operative housing was demolished with the construction of the JFK Boulevard (Route 18), a 1946 building permit identified the property owner as the Santo Christo Club and its most recent affiliation has been with the United Social Club a Cape Verdean community organization; and therefore, "the NBHC has determined that 460 South Front Street is not a historically significant structure and not preferably preserved."
