Councillor Coelho called the Appointments & Briefings Committee Meeting to order and took attendance. The Clerk informed the Committee that Councillor Dunn called to say he would not be in attendance as he had a conflict.

Notice, City Clerk of reference of a PUBLIC HEARING on an APPLICATION, Matthew F. Braccia, d/b/a U-HAUL International, Inc., for a SPECIAL PERMIT for Motor Vehicles Sales and Rentals, at 429 Church Street, New Bedford, MA 02745 (Application Rec'd 04/13/2020) (Duly advertised in The Standard-Times on Wednesday, May 27, 2020 and Wednesday, June 03, 2020.) was received and placed on file and the hearing opened by Councillor Lopes and seconded by Councillor Markey. (1)

Mr. Stoyan Kuvachen, Manager for U-Haul Southern Massachusetts was present and addressed the Committee. He told the Committee they will be placing a U-Haul at 429 Church Street, which is the old Plumbers Supply building consisting of 85,000 square feet. They will have a storage facility in the rear, and a store/retail area in the front to sell shipping and mobbing materials, boxes, tape, etc. They will have approximately twenty-five (25) trucks on the premises, but they will be rented out. Cleaning of the trucks will be done on site. Repairs will be done at their Brockton repair facility. The truck rental portion of the business will be opened first. Followed by the storage area once constructed. Customers could rent online or come into the facility. Most are done online because of COVID-19.

Councillor Morad asked about the hours of operation and she was told they will be Monday – Saturday 7 am to 7 pm and Sundays 7 am to 5 pm. She asked how many people will be in the facility at 7 am, she was told on the average five (5) to ten (10) people. She asked about storage access, it will be by key code and access twenty-four (24) hours a day. No onsite security personnel but their will be cameras; in case of an emergency the General Manager lies in Fall River, twenty-two (22) miles away.

Councillor Morad asked Danny Romanowicz, DIS Commissioner if the applicant met all the requirements. Commissioner Romanowicz said that they did, and he is pleased with the plan submitted. He reminded the Committee that on the left side of this building is where the train would be stopping, and the right side would be open to commercial traffic.

The Committee discussed changing the hours of operation. Attorney Gerwatowski stated that you could change them prior to issuing the permit, but once issued you could not go back mid-issuance and change it again. Commissioner Romanowicz reminded the committee that the noise ordinance allows for such business to operate between the hours of 7 am and 10 pm. The applicant also reminded the Committee that the hours of operation would be the same as the business that previously occupied the space.

Councillor Giesta welcomed the business but thought an hour change should be considered.

The Chair asked if there was anyone present who wanted to speak in or be recorded in favor of the petition; there was none. The Chair asked if there was anyone present who wanted to speak or be recorded in opposition of the petition; there was none.

Councillor Lopes made a motion to close the public hearing, which was seconded by Councillor Abreu. This motion passed on a voice vote.

On motion by Councillor Giesta and seconded by Councillor Abreu, the Committee VOTED: To recommend to the City Council APPROVAL of the APPLICATION, Matthew F. This motion Passed on a Roll Call Vote of Yeas 9, Nays 2, with Councillor Gomes not present for the vote.
