Councillor Abreu asked her about her position on the homelessness issues in the downtown area. She told the Committee that the homelessness issue is deep routed through other causes that should be addressed while dealing with the issue in the downtown area.

Councillor Morad reminded the applicant that the Parallel Project proposed in the far north end would be coming before the Board of Health and asked her to make herself familiar with the issues. Dr. Griffith stated, she was aware of the issues and would look at the project through an independent perspective.
