WHEREAS, Joseph P. Lopes is the son of John R. and Dorothy D. Lopes, has a brother John and a son Joseph; and

WHEREAS, Joseph P. Lopes graduated from New Bedford High School, Bristol Community College, majoring in Business Management, the University of Massachusetts-Dartmouth earning a Bachelor's of Arts Degree in Political Science, and in 2002, graduated from Johnson and Wales University, earning a Master's Degree in Business Administration with a concentration in International Business; and

WHEREAS, First elected to public service in November 2009, Councillor Joseph P. Lopes has Chaired the Committees on Veterans Affairs, Elderly, Health, Housing and Disability Issues, Labor and Industry, Finance, and the Special Committees on Budget Review, and was a member of the Committees on Appointments and Briefings, City Property, Audit, Fisheries, Ordinances, Public Safety and Neighborhoods, Internal Affairs, the Special Committees on Environmental Affairs, Gaming and Casinos, Soccer Fields, Charter Revision Commission, Employment Opportunities and Memorials and Dedications; and

WHEREAS, Always a strong voice for the people of the South End, Councillor Joseph P. Lopes made sure the concerns of Ward Six were brought to the forefront in City Council Chambers and worked for years to improve the South End of the City by way of his knowledge and experience; and
