Councillor Carney called the Appointments & Briefings Committee Meeting to order and took attendance. The Clerk announced he received a call from Councillor Baptiste stating he would not be present at tonight's meeting.

Celeine Saraiva, New Bedford, was present and explained that she has been on the Panel since 2019 and they have only dealt with one issue. The Committee asked Ms. Saraiva if she had a preference of what board she would like to serve on as she was being recommended for the Council on Aging as well. She stated she would like to serve on both, but if she had to choose, she would like to serve on the Problem Properties Appeals Panel.

Ramon Silva, New Bedford, was present and addressed the Committee. He told the Committee that he was in favor of a helicopter pad or landing facility at the airport. He explained that he saw the airport as a major drive towards economic development specifically in the area of cargo, construction, and service. He also, stated he was in favor of commercial airlines in the city as well.

Mr. Silva was asked if he found his day position as a member of the New Bedford Economic Development Commission to conflict with this position and he stated that he did not; but that if an issue did come up, he would recuse himself from voting at either one.

Councillor Morad offered up reservations in a city and/or quasi city employee serving on Boards. She was not in favor of this appointment, though stressed it had nothing to do with the applicant.

On motion by Councillor Dunn and seconded by Councillor Markey, the Committee VOTED: To recommend to the City Council APPROVAL of the APPOINTMENT of RAMON SILVA, New Bedford, MA, to the AIRPORT COMMISSION, Mr. Silva will be replacing William Peter Gushue, who has resigned; this term will expire December 2022. This motion passed on a Roll Call Vote of Yeas 9, Nays 1, with Councillor Morad opposed.
