WHEREAS, Mark McGraw, a native of Ithaca, New York, was born in November 1962, is the son of Jack and Jacqueline McGraw, was married in March 1990 to his devoted wife Paula and is the proud father to their quadruplets Andrew, Patrick, Michael and Kate, and grandfather to his beloved one year old granddaughter Charlotte; and

WHEREAS, Because of his father's dedicated career a United States FBI Agent, Mark and his family resided in several cities, finally settling in New Bedford, where in 1981 Mark graduated from Bishop Stang High School, joined and served in the United States Army until his discharge in 1988, returned home and enrolled in and graduated in 2000 as a Registered Nurse from Bristol Community College; and

WHEREAS, While attending Bristol Community College Mark McGraw successfully completed an Emergency Medical Training program and was hired by the City of New Bedford's Emergency Medical Services Department in 1989 as a part time Intermittent EMT, obtaining full time status in November 1990, and continuing to advance his career as a member of the Department by becoming a Paramedic in 2003 and Field Supervisor from 2006 until February 2009 when because of budgetary cutbacks as a result of the nationwide recession he was laid off the job along with his fellow Field Supervisors; and

WHEREAS, Thankfully, in July 2009, Mark McGraw was rehired by the City of New Bedford, when then Mayor Scott Lang offered the position of Director of the Emergency Medical Services Department to Mark McGraw who immediately began the process of rebuilding and expanding the department, hiring additional EMT's and Paramedics and encouraging them through education to advance their careers in the field of Emergency Medical Services; and

WHEREAS, Since his appointment as Director, Mark McGraw has overseen the professional operation of the City of New Bedford's Emergency Medical Services division, has developed and maintained various City emergency operation plans; instituted the Special Response Team in conjunction with the New Bedford Police Department to respond to high risk emergency situations such as the tragedy at the Foxy Lady, has strengthened the department's working relationship with surrounding towns, private ambulance services and local medical providers, partnered with the South Coast Hospital Group to modernize and expand communication services, all with the goal of providing the best possible emergency care to patients at the point of engagement and in route to the hospital emergency room; and

WHEREAS, The City of New Bedford was so fortunate to have Mark McGraw at the helm in the last two years of the unprecedented COVID-19 pandemic, where his years of dedication and experience allowed him to lead the department through this critical time, keep his employees and their families safe while continuing to deliver professional and compassionate Emergency Medical Services to the City's residents; and

**WHEREAS**, The City and people of New Bedford have been so blessed by the fact that Mark McGraw has, for 32 years, dedicated himself to the community where he leaves behind the great legacy of having changed the image of the City's Emergency Medical Services Division to well-equipped and professional operation staffed by dedicated, talented and hardworking employees who, over the years, have become an extended family to him; and

#### RESOLUTION HONORING YOUR THEATRE, INC., ON THE OCCASION OF THE CELEBRATION OF THEIR 75<sup>TH</sup> ANNIVERSARY

**WHEREAS**, The origin of Your Theatre, Inc., began in September of 1946, when Mary A. Smith, a professional actress and dedicated teacher, founded the community-based nonprofit theatre as a means to enhance the cultural life of the Greater New Bedford Community, and to develop and encourage dramatic art, while entertaining local audiences; and

**WHEREAS**, From the Theatre's first production of The Barretts of Wimpole Street in 1947, staged at the Fairhaven Town Hall, to this year's 75<sup>th</sup> Season opening production of Jeffrey Hatcher's The Viewings, Your Theatre, Inc., has for seventy-five years been at center stage, entertaining generations of South Coast audiences; and

**WHEREAS**, In the early years, Your Theatre, Inc., performed at a variety of venues such as the Fairhaven Town Hall, the County Street New Bedford High School Auditorium, Kenyon-Campbell School, Keith Junior High and the Parker Street Mini Theatre, while members of the theatre company fostered the dream of a building they could call their own; and

WHEREAS, In the spring of 1961, through the generosity of Rudolph Brenneke, Your Theater, Inc., rented the building at the rear of 100 Parker Street, which was converted to a small theatre and became the Theatre's home for the next 18 years, as the theatre company staged over 50 productions ranging in diversity of theme and securing Your Theatre's reputation as a treasure for live theatre in the Greater New Bedford area; and

WHEREAS, In September 1979, in conjunction with the City of New Bedford, Your Theatre Inc., assumed occupancy of the New Bedford Textile School, located at 71 Maxfield Street, and renovated the facility into the most fully equipped community theatre of its kind in Southeastern Massachusetts, building an 88 seat main theatre and a 44 seat mini-theatre, and allowing the theater company to expand and diversify operations to a variety of new and exciting productions; and

WHEREAS, Your Theatre, Inc., remained at the Maxfield Street location, until November 2004, when the Theatre moved to the present location at St. Martin's Episcopal Church, where Your Theater has hosted over 75 productions and continues the original mission of providing diversity and excellence in theatre, priding itself on being the most professional, nonprofessional theatre group in the area, and inviting new volunteers to join this small, fiercely independent theatre company, which provides numerous opportunities for experienced actors and newcomers, both on stage and off; and

WHEREAS, In 2014, in conjunction with WHALE, Your Theater, Inc., took the first steps in planning to make the long awaited dream of owning own their own state of the art theater facility come true, acquiring the former First Baptist Church on William Street and beginning a multi-year \$3 Million dollar construction project to renovate the building to be the new home of the Steeple Playhouse Performing Arts Center, where the theatre will be able to once again expand theatrical productions and continue to provide the greater New Bedford community with an outstanding community theatre company; and

**WHEREAS**, After almost eight years of fund raising, grant writing, exhaustive planning, permitting and renovation work, Your Theater Inc., looks forward with excitement and anticipation to the December 2022 celebration and ribbon cutting of the Steeple Playhouse Performing Arts Center and another 75+ years of outstanding community theatre productions:

**NOW, THEREFORE, BE IT RESOLVED**, That the New Bedford City Council hereby commends and congratulates **YOUR THEATRE, INC.**, a true treasure of community theatre, and all the volunteers throughout the past 75 years for their commitment and dedication to local community theatre and the performing arts, eagerly anticipates the opening of the new theatre facility and the continuation of outstanding theatrical productions for many years to come.
