Gary Lunsford, Milwaukee, WI, was present to answer questions from the Committee.

He was asked a series of questions by the Committee as it related to his past work experience and what new ideas, he would bring to the city's zoo. Mr. Lunsford explained that he currently serves as the Director of the Milwaukee County Zoo. He has thirty (30) years of experience in the area of animals, beginning in 1995. He believes his present position fits well with the New Bedford position as it is similar. He intends to take that experience and apply it to the city's zoo. He is looking forward to this new opportunity. He is excited to contribute to the growth of one of the greatest small zoos in the country. His initial goal once in the position would be to focus on getting the zoo prepared for this next round of certifications. He wants to find out where he can be most effective in the position and hopes to install an ambassador animals' program and contribute to a good visitor experience for those who visit the zoo. He confirmed that he is familiar with budgets and will look to bring strategic thinking to the position. He will make increasing attendance one of his top priorities.
