Executive Director's Report

Cynthia Wallquist reviewed the projects funded to date for this fiscal year:

- Architectural Services
- Clear Path
- Special Needs Exercise

Esperanza moved to accept the Executive Director's report; George seconded. Roll call vote. All in favor.

Architect's Report

Architect BG Shanklin reported updates on the following:

- Alma Del Mar variance; new campus on Church St.
- 130 Arnold St deli; applied for variance but nothing yet
- Buttonwood warming house; no occupancy certificate yet as there are still issues with the bathrooms
- Café Italia signage is still not located correctly; George Smith suggested contacting the Building Department
- City Hall signage still needs to be posted at the foot of City Hall steps indicating that the accessible entrance is on Sixth Street
- City Hall doorbell and door repair complete
- City sidewalks adjacent to Walgreens are being redesigned by DPI no installation date set yet
- First Congregational Church (Lund's Corner); consulting on renovation of 1st floor space
- 90 Hatch St. Studios can't get occupancy but will continue to work to meet code
- Hillman St. ramp COA; need 2 ramps for both doors to entrances as the front entrance is not accessible and the accessible door is located in an active driveway too far from handicapped parking space
- PAACA signage needs to be removed/not needed because correct signage is there
- W. Beach Pavilion: no update on grant for redesign; BG still waiting for the actual design
- Parks and Recreation Braille signage project creating uniform signage at all park locations was supported by the Commission
- Temple Landing expansion is under review by several departments; The Chair will be submitting on behalf of the Commission (needs handicapped parking and curb cuts)
- St. Anthony's Church requested a variance that is not needed as a newly installed "lift" satisfied all requirements
- NBHS: providing assistance re: 2 bathrooms adjacent to the auditorium

Kim Bettencourt moved to accept the Architect's Report; Pam Cole seconded. Roll Call vote. All in favor.

New Business

- The Commission received a complaint from a Tripp Towers residents stating that the accessible bathrooms in the common areas have been closed. The commission will forward the complaint to the NBHA for comment.
- George Smith reported that he "attended" the ARPA public hearing and spoke on the need to:
 - Address ADA issue on City properties
 - Construct a Senior Center that includes space for exercise, wellness programs and multi-purpose rooms
 - Expand broadband access
 - Create senior housing
 - Address Age-Friendly priorities
- George volunteered to tour City sites in his motorized wheelchair with the Mayor to show the issues facing residents who have mobility issues.
