From 2019 to present the H.R.C. has advocated for health equity within the community. The H.R.C. was instrumental in establishing Prostate Cancer Awareness week in New Bedford to educate and encourage support against the mortality rate, which is higher in Bristol County than in the rest of the State.

In 2018 the H.R.C. was instrumental in establishing Human Rights Day in the City of New Bedford on December 10,2018.

In June 2010 through a grant from the Greater New Bedford C.OA.S.T., the H.R.C. in collaboration with the New Bedford Women's Center developed the first brochure to address domestic violence within the Mayan community.
