The Officers noted in their report that the incidents that do occur are discovered by officers when they drive; adding that the business does not call police when they have a problem and that the owner/ manager of the establishment has never co-operated with police when they discover a problem at this establishment.

It is illegal for anyone under the age of twenty-one years to purchase or be in possession of an alcoholic beverage; identification must be checked on the day of service.

ABCC Regulation 204 CMR 2.05: (2)-

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises.

Licensing Board Regulation No. 5, 6, & 12-

Sale of alcoholic beverages, wine and malt beverages to persons under twenty-one years of age is prohibited; Alcoholic beverages shall not be served to a person who is or appears to be intoxicated; Premises must at all times be kept safe.

Summary of Incident Report

The Police Department Incident Report states that an Officer, while on a routine patrol traveling north on Dartmouth Street in the vicinity of Rivet Street, observed a large disturbance forming at the entrance to The Bar located at 266 Dartmouth Street. Upon arrival, the Officer observed 10 people yelling at each other and being pulled apart. After radioing communications, the Officer activated the Blue lights on his cruiser and exited his cruiser; as the Officer approached the group, it began to separate in half and the security staff was yelling for everyone to get against the wall and they were complying, however, the two groups were yelling back and forth.

The Officer was told by a female who stated that the altercation was started by The Bar staff, adding that the bartender threw a drink at them, referring to their group of friends, and assaulted them.

As the Officer was talking to the first female, he observed a second female who was being held back by several persons, while yelling back at the bar staff; moments later, she pushed away from her friends and lunged towards the staff at the entrance to the bar in what he observed to be an attempt to assault the staff, at which time, he made a decision to place her into custody.

The Officer then interviewed the bartender who stated that she asked one of the males to close out his tab, at which time she received an attitude from the group. She replied that the attitude was unnecessary and was told by one of the females that they were not leaving until they finished their drinks, at which time she took away the drink. The bartender stated that caused the female to come into the serving area behind the bar for what she believed was to fight her; adding that the girls in the group threw glasses at her and at the stage with one hitting a customer, although no victim came forward or has been identified.

The Officer then escorted the male back into the bar to close out his tab, at which time the Officer asked him his date birth to which he responded that his date of birth was 10/26/97. Upon running the male's name through the system, it was discovered that the male's date of birth was 10/26/98, which made him 20 years of age and not of legal drinking age.

Along with the first female, a second was also placed into custody and charged with disorderly conduct as well.
