Mr. Beard responded, it doesn't sound like the same deal, they've been closed a lot longer than I have, to which Chairman Beauregard responded, well, that's something you can take up with ABCC when the time comes at your appeal with the ABCC. When asked by Mr. Beard if the Board was giving up their jurisdiction to the ABCC regarding the appeal, to which Chairman Beauregard responded, it's not that we're giving up our jurisdiction, it's the way the process works ... we make our decision ... and you have an opportunity to appeal our decision to the ABCC to make your argument ... they could possibly allow you to have an extension ... but they don't allow 'pocket licenses' ... over 6 months ...

so instead of 6 months ... we're going to give you a year ... you've already been afforded 6 months ... which by November will be over a year ... which we feel is giving you ample opportunity to move that license.

The following written decision was issued to the licensee on 01/25/18:

As you are aware from the Board's January 22 meeting, the Board voted unanimously to grant you until our hearing date of November 19, 2018 to activate or transfer your license by this time.

Should your license remain inactive come November 19th, said license will be revoked by this Board at which time you will have an opportunity to appeal this action to the Alcoholic Beverages Control Commission (ABCC).

Summary of Incident Report #1
