Minutes of 06/25/18 Meeting

Present: Licensee was excused from attending.

Mr. Nanopoulos informed the Board that he's been working with a representative from Atty. Medeiros's office, who is preparing an application for the changes that are required; so based on that information, he recommended that the matter be tabled to the Board's July meeting by which time an application should be submitted.

<u>Voted:</u> On a motion by Commissioner Almeida the Board unanimously voted to table the matter to the Board's July 23, 2018 meeting. – <u>Unanimous</u>

<u>Present:</u> Atty. Michael Medeiros along with his assistant, Andrew Beechinor; and Robert E. Benoit, President of Al's Dog House, Inc.

Mr. Nanopoulos opened the hearing by informing the Board of the issue that was before them by stating, due to the untimely death of family member who is an officer and stockholder in the corporation, which occurred two years ago, that a change of officers and directors and a transfer of stock are required. He went on to add that he's been in constant contact with both the licensee and Atty. Medeiros's office in order to get this matter resolved, which to this point has been to no avail; hence, the request for this meeting.

Atty. Medeiros stated, Mr. Nanopoulos has been very ... very co-operative with us over the past two years with regard to this issue and as Mr. Nanopoulos indicated ... Gail Pedro, who was my client's sister and was an officer and a one third owner in the corporation ... she suffered an untimely death on the premises ... so she has one legal heir ... there was no will ... so we've had those issues to deal with in probate ... he (heir) has not been the most co-operative individual to deal with unfortunately ... Although he has had counsel ... there have been some instances that counsel was unsure if he was going to continue to represent him during some of this ... our goal initially was to buy him out ... so there would be an agreement with one transfer from the estate ... not necessarily from any specific individual ... and the paperwork would be filed then ... however, an offer was made but a counter offer was never presented until about a two weeks ago ... but unfortunately ... our offer which we thought was fair and reasonable under the circumstances ... but when it comes back 4 times more than what we offered ... so obviously we're not there yet ... but we know we have to comply ... but Andrew has more information he can offer to the Board.

Mr. Beechinor offered the following by stating, so at this point ... we pretty much have everything that we need from our side to

submit the application ... the biggest thing has been trying to get the beneficial interest information from Shaun Sullivan, who is the heir ... as well as getting a CORI Form and an affidavit regarding anything that might be in his criminal background ... I think it was about two weeks ago when communication really started to break down ... so obviously with a contentious situation like that it can happen ... but last week ... with Atty. Hunt's assistance ... we've really started to make some progress ... it wasn't as quickly as we wanted to ... but we're very near be complete.

When asked by Chairman Beauregard if it's the intention to bring him into the corporation, Mr. Beechinor responded, the intention is to have him as the personal representative of the estate of Gail Pedro and have the estate be part of the corporation ...that's how he'd like it to be ... so the estate would be a stockholder in the corporation.

Atty. Medeiros added that the sticking point in the process is getting Mr. Sullivan, who is the sole heir to Ms. Pedro's estate, to co-operate to get this resolved. Atty. Medeiros expressed his frustration that Mr. Sullivan refuses to come to the table to negotiate with us, adding that in 22 years of practicing, he's never had a situation like this.

Mr. Beechinor added, so at this point it doesn't look like we're going to be able to reach an agreement to buy out his shares, so it look like ... short term ... we're going to add the estate as a stockholder of the corporation.

When asked by Chairman Beauregard if you could have an estate as a stockholder, Mr. Nanopoulos stated he thought it would be allowed but added he would double check with the ABCC.

Atty. Medeiros added, I'm hoping we can make a little more headway with this ... for more of a global resolution to this ... so that there would only be two shareholders in this corporation ... however if you asked me a year ago ... I would have told you we were close then.

Chairman Beauregard responded, I think you have to tell him that he is putting the license at risk of being lost if this matter is not resolved; to which Atty. Medeiros responded, we've told him that ... his Attorney appreciates that ... but he doesn't ... there really isn't any communication between him and the family ... I think it's been like that for a long time ... even before his mom passed away ... so I just think this just labors it a little bit more, unfortunately.

Chairman Beauregard suggested that the matter be tabled till November with the understanding that word be sent to his attorney that come November, there's a potential that you could lose the liquor license.

Chairman Beauregard offered that the Board would be willing to put something in writing expressing the Board's view on this matter, to which Atty. Medeiros responded, I would be happy to forward that letter to Mr. Sullivan and his legal counsel. Mr. Nanopoulos suggested that either Atty. Medeiros or Mr. Beechinor contact Ralph Sacramone at the ABCC to see if adding an estate as a stockholder is acceptable before they start on the application, if they go in that direction.

<u>VOTED</u>: On a motion by Commissioner Almeida, the **Board voted unanimously to table the matter until this Board's** November 19, 2018 meeting with stipulations,

Board's Written Decision of 08/10/18

As a result of the open hearing held on July 23, 2018 to determine whether you have violated certain provisions of Massachusetts General Laws and Licensing Board Rules and Regulations, this Board **voted unanimously to table the matter until the Board's November 19, 2018 meeting**.

Issue Summary

Since that untimely death of a family member (Gail Pedro), who served as a Director and Stockholder (100 shares), this office has made numerous attempts to get a very important matter resolved. Under M. G. L. you are required to submit an application for a change of Officers, Directors, Stockholders, and a Transfer of Stock.

The Board's decision was based on you and your Attorney's assurance that this matter will be resolved with a family member regarding the dispersion of outstanding stock in order for an application to be filed to reflect the changes in the corporation, as required by law. The Board feels that this extra time is more than sufficient to resolve this matter.

An application must be submitted by November 1, 2018, so that it may be considered on November 19, 2018 by this Board. Failure to resolve this matter in a timely manner may result in your license not being renewed for 2019.

As you were aware, you and Mr. Gil were requested to attend the Licensing Board meeting of June 25, 2018, yet both of you failed to attend. Your failure to attend is compounded by the fact that you both neglected to inform the Board of your inability to be present.

In January 2018, you informed this Board that you would remain as manager and Attorney Markey would be filing for a Change in Officers and Directors.

The Board elected to table the matter with the understanding that this paperwork would be filed in a timely manner. To date, that has not been done.

Please be advised that you have until July 6th to submit an application along with a Certificate of Good Standing from the Department of Revenue or your license will be suspended immediately. The Board has made repeated attempts to assist your establishment but your continued failure to act necessitates this action.

At the Board's next meeting of July 23, 2018, the board will determine what, if any, additional action needs to be taken. Your presence as well as Mr. Gil's is required at this hearing. Hearing time is 7:00 P.M. in Room 314. As a result of your failure to comply in a timely manner, the Board will entertain testimony as to the actions of the United Fishermen Club, Inc. Short of full compliance, the Board must take action and as such you are hereby ordered to bring with you your 2018 Liquor License. Depending on the Board's findings, you may be required to surrender your license until this matter is resolved.

ADOPTED FOR 2018

- ✓ ICS command center will be manned by NBPD, NBFD, Feast committee, EMS (located in main hall). ICS contingency plans have been followed including preliminary security meetings with all department heads, and table top exercise with St. Luke's Hospital group.
- ✓ Current security system upgraded with all new cameras, (2) 65" monitors, laptops and operating system to include 10 wireless cameras, wireless cameras from Almar de Mar school, and NBPD cameras. Total cameras in use will be approximately 32-36 cameras. Cameras have been added in all locations that were deemed to be "not covered" by the current system. Presumably the entire grounds including the perimeter should be covered by all cameras when operational.
- ✓ Jersey barriers are being replaced with sanding trucks from DPI and or Fire trucks at all "entrance" points affording greater protection and ease of movement in case of emergency, bollards will be placed in sidewalks to stop possibility of cars driving on them and injuring patrons. In addition there will be 12 light towers in use this year over 3 last year to ensure that the perimeter is well lit for patrons and emergency personnel for everyone's safety. EXIT signs will be painted on the ground directly in front of all exits and will include arrows properly placed to designate the correct direction of travel to exit. In addition photo luminescent exit signs will be attached to all gates that abut these exit areas.
- ✓ An additional gate has been added in the middle of the Feast grounds on the Hathaway Street side affording another form of egress and regress. This gate will be approx... 24-28' in length while open and will allow for better flow of patrons during normal hours of operation as well as in the case of an emergency situation.
- ✓ System upgraded has been completed for communications to designate all emergency personnel to one primary channel for entirety of the Feast. This allows emergency personnel direct use of a designated channel (5) so as not to interfere with normal operations of police and fire channels. A separate dispatcher will also be designated solely for the Feast on this channel.
- ✓ Gillette stadium protocol as it pertains to bags has been adopted and will be enforced and posted on the Feast website. Again there will be no backpacks, clear bags only, and all bags are subject to search.

Decision: The Board unanimously voted to receive and approve the 2018 Feast Security Plan, and place it on file.
