The following written decision was issued to the licensee on 01/25/18:

Although you failed to appear at this Board's January 22 meeting as requested, the Board chose to extend you the same courtesy as those that did appear, and voted unanimously to grant you until our hearing date of November 19, 2018 to activate or transfer your license by this time. Should your license remain inactive come November 19th, said license will be revoked by this Board at which time you will have an opportunity to appeal this action to the Alcoholic Beverages Control Commission (ABCC). The decision of the Board is supported by MGL Chapter 138, Section 77 which states that "the Licensing Authority may, after hearing or reasonable opportunity there-fore, cancel any license issued under the chapter (138) if the licensee ceases to conduct the licensed business, that is, any license holder who closes the business or stops doing business."
