The meeting will include Capt. Adelino Sousa, Liaison to the Licensing Board and Capt. Thomas Flood,
Detail Officer for Special Events.

With regard to this year's event, this Board is looking forward to working with you and your committee with the hope that you embrace the outstanding plan that has formulated over the past several years, and that, if possible, explore ways to improve on the plan.

We fully anticipate that this year's committee will work with us to help ensure that the 103^{rd} Feast of the Blessed Sacrament, which is very important to the Portuguese Community, the City of New Bedford, and to all that travel from afar to enjoy and partake in the celebration of the Madeira heritage, remains a safe and enjoyable event for all.

PREVIOUSLY ADOPTED:

- The Feast grounds perimeter that patrons will be traveling in and out of, which includes the 'Feast and the Carnival area' will be enclosed with <u>only four (4) entrances/exits locations</u>. (See Attached Plan)
- Each entrance/exit will be manned by Police Officers full time and they will be responsible for not allowing alcohol to leave that area.
- ✓ The Feast Committee <u>agreed to hire five (5) additional officers for each night</u> of the Feast, who will be used to contain the alcohol in the enclosed area.
- ✓ Post signs at all entrances & exits "No Alcohol Beyond This Point".
- ✓ **Set up barrels at all exits** to help deter persons from leaving the contained area with alcohol.
- I.D.'s will be checked before issuing wristbands: also anyone consuming alcohol will be monitored to make sure they have a wristband and spot checks of person's with wristbands will be done to make sure they have proof of age on them.

- The Feast Committee has also <u>agreed to keep nine (9) Officers an additional hour (until 2:00 a.m.) to provide extra security for the neighborhood</u> and they will patrol the immediate neighborhood to ensure that those persons leaving the Feast Grounds do so in a timely manner with as minimal an amount of disturbance to the neighborhood as possible.
- ✓ They also <u>have eliminated the 28 oz. containers of Madeira Wine</u>, which will only be sold in 3 oz. & 7 oz. cups, which should eliminate some of the problems with intoxication and the consumption of the wine by minors purchased by persons of age. (New)

Chairman Beauregard once again stated his desire to see the alcohol contained within the fenced in feast grounds, by stating that this is the last weak spot we have, which is the sale of alcohol out onto Hathaway Street; and that is the place we have alcohol coming off the grounds and that is the only area where we don't have the control we would like to see.

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises.

Licensing Board Regulation No. 6, 10, 11, 12, 24-

Each corporate licensee shall appoint a manager (by a properly authorized and executed written delegation) who shall have full authority and control of the premises, and who shall be satisfactory to the Board, and who shall be a United States citizen. Immediate notice of the appointment must be made to the Board in writing; Alcoholic Beverages shall not be served to a person who is or appears to be intoxicated; Objectionable persons shall not be permitted on or about the premises, and it is the responsibility of the Licensee to enforce this rule; Premises must at all times be kept safe; There should be no disorder on the premises or areas connected therewith.

Summary of Incident Reports

Police Department Incident Report states that Police Officers received a call about a possible stabbing at the Garden Restaurant & Bar, located at 32 Barker's Lane. Upon arrival, officers observed a fellow officer taking out his medical bag and getting ready to render aid to a male bleeding profusely from his lower back side. According to a female witness, the victim was only trying to help separate two other males that had been fighting outside the Garden Bar, and she witnessed one of the males forcefully stab the victim in the lower back. When questioned by the officers, the staff at the Garden Bar was uncooperative and did not assist with any information that could help identify the suspect male in any way although he was observed to be a patron inside the bar on this night. The reporting officer's first conversation was with a male who continued to ask why he needed to ask questions since according to him: "it didn't happen in here, it didn't happen inside, it happened out there." The officer noted in his report that he was rude and reluctant to give him any further information. When the officer asked all present if anyone had the number of the person who could access the camera system, and after getting no response; the Reporting Officer noted in his report that he was getting the impression that the staff at the Garden did NOT want anything to do with this incident or did not want to get involved in any way by evading and NOT answering any questions related to this incident.

The Reporting Officer then told the staff that this was an ongoing investigation and that detectives would be there soon, and that they may wish to speak to them; at which point two male staff members stated that there was an issue inside with two males, nothing serious they said, but (earlier, unrelated to the stabbing) that they had asked them to go outside and they did. When asked by the Reporting Officer if anyone remembers the victim who was stabbed outside, if he had been drinking inside, they both said yes and then he went outside, and that's all they could recall.

The Reporting Officer then went back outside through the Barker's Street exit to relay some of this information, and by the time the detectives arrived on the scene, the detectives noticed that the lights were off inside and the staff had left through the front entrance to Union Street; at which point there was no access to the establishment, and there was notice given by the staff they were securing and getting ready to leave; this after being told earlier by the Reporting Officer that this is an ongoing investigation and that detectives would be there soon, and that they may wish to speak to them.
