Also, we respectfully request you submit a 'Security Plan', along with a 'Vendor Map' to this office **by April 17, 2017**, which would address the following issues:

- Alcohol Service # of Drinks/Cups
- I.D. Checks and the Issuance of Wristbands
- Flow and Control of Alcohol
- # Of Police Officers
- Hours of Operation Starting Times/Closing Times/Last Call/etc.

With an eye to this year's event, this Board is looking forward to working with you and your committee, and we would hope you would continue the improvements that have been implemented over the past few years, and that you explore ways to improve on that plan, with regard to I. D. check's; and to address the issue of how the I.D. bracelets are issued. We fully anticipate that this year's committee will work with us to help ensure that the 'Day of Portugal' event, which is very important to the Portuguese Community, the City of New Bedford, and to all that travel from afar to enjoy and partake in the celebration of the Portuguese heritage, remains a safe and enjoyable event for all.

Also, please be advised that this year's deadline for each individual to file an application and submit the licensing fee of \$450.00 for a Special Three - Day Liquor license for this year's event, which is scheduled for Fri. – Sun. – June 9th, 10th, & 11th, is **Monday, May 15, 2017.**

As the committee has done in the past, it would be greatly appreciated if you would supply this office with a list of those that will be participating in this year's event ASAP, which should include the organization/ or business name, contact name, and phone #, so that this office can make sure that everyone applies in a timely manner.

The requirements will be the same as last year, which included that everyone will be required to apply for an All-Alcoholic license for each of the days (3) for a total fee of \$450.00 (payment due w/application); also, so that there is uniformity among all participants, each license will be issued with the same hours and restrictions as follows:

- FRIDAY, JUNE 9th 5:00 P.M. UNTIL 11:45 p.m.
- SATURDAY, JUNE 10th 12:00 P.M. UNTIL 11:45 p.m.
- SUNDAY, JUNE 11th 12:00 P.M. UNTIL 10:00 p.m.

<u>NOTE:</u> Only holders of Special One Day Licenses are allowed to serve alcohol in <u>plastic cups</u> from either booths set up along Acushnet Avenue or from inside licensed premises, *which must be consumed within the confined area of the festival* – Steven A. Beauregard, Chairman – N.B. Licensing Board.

NO BOTTLES OR DRINK GLASSES ARE ALLOWED ONTO THE STREET ALL DRINKS ON THE STREET MUST BE IN PLASTIC CUPS

<u>Present</u>: Carlos Pinhancos, Feast President along with Dulce Matos, Vice-President and Angela Amaral, Advisor Responding to questions from Chairman Beauregard, Mr. Pinhancos stated, we've made a few changes planned for this year's event by downsizing in an attempt to try to control our costs... so we've eliminated one stage, which will leave one stage at the corner of Holly and Acushnet Avenue ... and the other is we're cutting down on the number of liquor vendors ... so right now we've got five locations ... not eight as we normally do ... adding that it would be Cafe Europa, Cafe Portugal, Adriana's Mexican Restaurant, Mi Antojo Mexican Restaurant, and our two booths (Day of Portugal Committee) ... and we may even cut our booths down to one ... but we have not made that decision as of yet.

When asked by Chairman Beauregard if they've met with the Police Department with regard to police details, Mr. Pinhancos replied, we're meeting with them tomorrow; adding, by shrinking the area down, we're trying to shrink that cost down as well.

When asked by Chairman Beauregard if the attendance has stayed relatively the same, Mr. Pinhancos stated that the attendance has dropped the past couple of years, so that's why we've cut it back this year as well.

When asked by Chairman Beauregard if the distances would be staying the same, Mr. Pinhancos stated that the distances would be staying the same but there wouldn't be anything in those blocks; he also stated that he hasn't heard from the church yet as to whether they would be doing anything but they usually wait to the last minute to inform us.

Mr. Pinhancos added, as far as changes ... that will be it ... our rules that we've submitted to you are pretty much as they have been in the past ... security plan is pretty much the same ... hours of operation are the same ... all the streets will be blocked off ... wristbands are still the same ... each vendor is responsible for checking I.D.'s and issuing wristbands. Mr. Nanopoulos informed the committee that the applications must be applied for by May 15th along with a check for \$450.00.

ACTION TAKEN: The Board unanimously approved the 'Security Plan; and the 'Changes' that were submitted.

Your presence and that of Michael Tavares and Danny Furtado, Bouncers, is requested at a hearing to determine whether you have violated certain provisions of M.G. L., ABCC Regulations, and Licensing Board Rules and Regulations. Based on their findings, the Licensing Board may take action to modify, suspend, revoke, or cancel your license. They are as follows:

ABCC Regulation 204 CMR 2.05: (2)-

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises.

Licensing Board Regulation No. 10, 11, &12-

Alcoholic Beverages shall not be served to a person who is or appears to be intoxicated; Objectionable persons shall not be permitted on or about the premises, and it is the responsibility of the Licensee to enforce this rule; Premises must be kept safe at all times.

Summary of Incident Report #1

Police Department Incident Report states that Officers were dispatched to a disturbance in the rear of Slainte Irish Pub on Commercial Street along with a report that there may be a fight in the front of the building, which required a response from multiple units.

Upon arrival there was a separate fight in the rear of Slainte. Upon dealing with that incident, the reporting officer went to the front of Slainte, where he was directed to a victim of an assault that occurred inside of Slainte. The victim identified himself as Michael Tavares who stated he was working as a bouncer that evening, and had a laceration to his forehead and was bleeding. When he was asked as to what had happened, he stated that there was a large fight involving 15 to 20 patrons inside the bar that were asked to leave by another bouncer. He stated that while escorting them outside, one of the patrons punched him two or three times in the face and fled.

Another bouncer, identified as Danny Furtado, was also assaulted after a patron was cut off by the bartender when he refused to leave the premises.

Date and time of alleged violations: Sunday, March 19, 2017 @ approximately 1:09 a.m.

Police Report # 17-3087-OF

Summary of Incident Report #2

Police Department Incident Report states that multiple units were dispatched to the area of Rte. 18 and Union Street for a large fight/physical altercation, which started at Slainte Irish Pub and spilled out on the sidewalk near the old National Club; which involved members of a wedding party and several of the bouncers from Slainte. The reporting officer stated that the altercation was over prior to his arrival but it was clear that there was a significant fight.

The officers observed several people on the sidewalk from the wedding party that were screaming and yelling; including two males who had ripped/un-tucked clothing and bumps/small cuts on them; along with another male who was transported to the hospital with a broken ankle. It was reported to the reporting officer that these males from the wedding party had been in a fight with the bouncers from Slainte. Several members of the wedding party were highly intoxicated. One of the medics on site informed the reporting officer that he recognized the "wedding party" from a call he went to earlier at another bar where one member had to be taken to the hospital because of a high level of intoxication; he also noted that the "wedding party" had been "causing problems" at the other bar as well.

The incident occurred when a heavily intoxicated member of the wedding party attempted to enter Slainte but was refused entry because of his level of intoxication and was asked to leave. According to a female witness who was the male patron, the door men from Slainte kicked the male patron out and as they were walking away down the sidewalk, several of the bouncers followed them and started assaulting the male patron they turned away. The female stated that she was also knocked to the ground by the bouncers during the altercation. When others from the wedding party saw the male involved in the altercation they began yelling and screaming and they too got into the brawl.

When the situation was under control, the officers made their way in to Slainte to speak to the bouncers. According to Mr. Furtado, who stated that he was the Head Doorman/Bouncer, stated that the male was the cause of the altercation as a result of his refusal to leave willingly after being told to do so; at which point they had to use force to get him out of the bar after he would not leave on his own accord. Mr. Furtado stated that during the initial confrontation that the male threatened him and grabbed him by the throat/neck; and that the altercation spilled outside where it worsened as others from the wedding party got

involved. According to Mr. Furtado, he and his bouncers were defending themselves against the attack.

According to a female witness, she pointed to Mr. Furtado and Mr. Tavares as the two more aggressive bouncers in the fight/altercation. The officers noted that none of the bouncers appeared to be injured.

The Reporting officers also noted in their report that there have been several unrelated altercations at Slainte Irish Pub in the near past; adding that on the same evening a male with a firearm in his possession had been arrested. He also stated that there was another large fight the prior weekend.

The bouncers assured the reporting officer that they have a pat-down/frisk policy on everyone as a precaution in an attempt to curb violent altercations.

As a result of the hearing, of which an audio version is on file; the Board, on a motion by Commissioner Almeida, voted unanimously to receive the report and place it on file.

The following written decision in part was issued to the licensee on 04/03/17.

Per your recent hearing regarding violations of Alcoholic Beverages Control Commission Regulation 204 CMR 2.05 (2) and Licensing Board Regulations 10, 11, & 12- on complaints reported to this Board by the New Bedford Police Department, the Board, based on the testimony presented by the Officers and discussing the matter in detail with you, voted unanimously not to take any action at this time with a warning that there must be a proper level of security at all times to ensure the safety of your staff and your patrons; as well as to ensure that disturbances or altercations do not occur.

This office once again reminds you of the following ABCC Rules and Regulations and Licensing Board Rules & Regulations:

Alcoholic Beverages Control Commission Regulation 204 CMR 2.05: (2)

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in or on a licensed premises;

Licensing Board Regulation No. 10, 11, & 12-

Alcoholic beverages shall not be served to a person who is or appears to be intoxicated; Excessive Noise, Crowds, and Objectionable Persons shall not be permitted on or about the premises. It is the responsibility of the Licensee to enforce this rule; Premises must at all times be kept safe....
