### MOTION TO ACCEPT THE MEETING MINUTES OF – February 27, 2017 - Unanimous

#### APPROVALS RECEIVED FROM THE ALCOHOLIC BEVERAGES CONTROL COMMISSION:

Altering of Premises (Addition of Sidewalk Seating & Change of Manager - Trans. # 02733-RS-0778 – Plot # 47--37 Moby Dick Brewing Company, Inc., David Slutz, President, who is petitioning to Change the Description of the Common Victualler (Restaurant) All Alcoholic Beverages license to include an outdoor patio area approximately 370 sq. ft. (37' X 10') to be used as a 'Sidewalk Café', which will be enclosed with 21" high planters that will be used to rope off the described area, and will be used for <u>seated dining purposes only</u>.

The enclosed area, which will include three (3) tables with seating for Eighteen (18) patrons, will be located on the north side of the building, which is contiguous to the licensed premises. The proposed outdoor area will only be accessible by way of an entrance/exit through the restaurant located in the front of the building, and will be accessible by 'Hostess Seating' only; the area will also be monitored by the hostess and waitstaff at all times. The proposed hours of operation are daily from 11:00 a.m. until 10:00 p.m., at which time all outdoor activity must cease, and shall be in effect from May 1<sup>ST</sup> through October 30<sup>th</sup>, in accordance, and as specified in the City of New Bedford Sidewalk Café Permit Ordinance. (Ord. Ch. 15, Article VI, sec. 15-100 (B) (Item #'s 8 & 15). The licensed premises will remain numbered 52 Union Street. The applicant is also requesting the approval of Timothy G. Cleland, who resides at 8 Atlantic Street, Plymouth, MA. as their new manager.

# Present: Justin LaCroix, Manager

Responding to questions from Chairman Beauregard, Mr. LaCroix stated, with regard to the fundraiser event on Friday night, it will be held inside the tents only as it has in the past, so, nothing is going to change with regard to that event.

Mr. LaCroix continued his remarks by stating that the Saturday event is the actual festival, so what we're looking to do with this event is to expand the enclosed area in front of the theatre so that liquor can be sold and consumed in the entire area; there will be security personnel at all entrances/exits to ensure that no one is leaving the area with alcohol, and we will also be issuing wristbands at the four entrance points from the street; and will be serving from the inside bar for this one; and the area will be enclosed with the metal bike rack type barriers from the city.

Mr. LaCroix then addressed the final event by stating, the Folk Festival is the exact same plan with one exception, the bar may be in the tent, if not we'll use the 'Z', which hasn't been determined as of yet bit it all be in the enclosed area with same security measures as the Viva Portugal event.

When asked by Chairman Beauregard if there would be Police Details, Mr. LaCroix stated, for the Viva Portugal event there were three police officers in that foot print last year, I'm assuming it will probably be the same; for the Folk Festival, I believe we had five for the event but only one or two in this area only, so that it would be covered at all times.

When asked by Chairman Beauregard as to the amount of attendees they anticipated for each event, Mr. LaCroix responded, the fundraiser on Friday, were capping that it at no higher than 200 inside the tent; the Viva Portugal is a free event so it's hard to say how many but it will be a number that will be influx all day but we did have a few hundred last year; and the Folk festival, we're looking to sell between 2,700 and 4,000 tickets but we haven't hit that yet; we will also be working with the downtown Captain to see what we need to set up as well.

<u>Voted:</u> On a motion by Commissioner Almeida the Board voted unanimously to accept the new set-up plans that were submitted; as well as the security plans for all three events.

The Pequod, Inc. d/b/a Rose Alley Ale House, 94 Front Street, is requesting the approval of Ryan K. Rapoza, who resides at 153 Davis Road, Westport, MA. as their new manager.

## Present: Ryan K. Rapoza, Proposed New Manager

Responding to questions from Chairman Beauregard, Mr. Rapoza stated, I've been a bartender there for four years ... I have bartender training and I'm T.I.P.S. Certified ... and I'm also ServeSafe Certified for the kitchen end ... and all his servers are T.I.P.S. Certified ... and this is my full time position ... and there would not be any changes to the current operation.

When asked by Commissioner Almeida as to how many hours he'll be on the premises, Mr. Rapoza responded stated that he would be on the premises at least Forty (40) hours a week.

<u>Voted:</u> On a motion by Commissioner Almeida, the Board **voted unanimously to approve the petition as presented**, and to forward the application to the Alcoholic Beverages Control Commission for their approval; with the stipulation that Mr. Rapoza submit a copy of his T.I.P.S. Certification to the Licensing Board office within thirty (30) days of receiving final approval or prior; and that all his servers be 'certified' as well, with copies of their certifications to be kept on file for review, if needed.

#### 5. PETITION - Trans. #00082-HT-0778 - Plot # 94--2

Emerald Partnership, LTD d/b/a New Bedford Inn & Suites, 500 Hathaway Road, is requesting the approval of James E. Hart III, who resides at 35 Monica Street, North Attleboro, MA. as their new manager.

#### Present: James E. Hart, III, Proposed New Manager

When asked by Chairman Beauregard to tell the Board as to what type of experience he has, Mr. Hart stated, I've been a ten year employee of the company of their residential properties in Cranston, R. I. and Massachusetts.

When asked by Chairman Beauregard as to what brought him to the N. B. Inn, Mr. Hart stated that the same owner I asked me to help out and take over the management of the inn due to problems they've had there the past couple of years, and try to clean it up.

Responding to Mr. Hart's comment that he was brought to try to clean it up, Chairman Beauregard informed Mr. Hart that the Board had received a Police Report regarding an incident that occurred over the weekend prior to this hearing and stated that the weekend didn't go quite well; to which Mr. Hart responded, no, it didn't ... there were a lot of problems ... but we co-operated as best we could with officers and detectives to get things done.

Prior to asking Mr. Hart further questions regarding the Police Reports that the Board had received regarding several disturbances at the motel, Chairman Beauregard stated that the Board was not going to take up the reports as violations at this hearing but they did want to ask Mr. Hart some questions with regard to the reports since he was mentioned in the

report; and that he was before the Board for requesting approval to named the new manager.

When asked by Chairman Beauregard if he was aware that event was going to be taking place on that Friday evening on March 24<sup>th</sup>, Mr. Hart stated that he was aware that the event was going to be taking place that evening.

When asked by Chairman Beauregard if thought that was something he didn't want to do, Mr. Hart responded, I didn't think an 18 year old event without alcohol would be an issue.

When asked by Chairman Beauregard, it probably didn't sit well with you, did it, Mr. Hart responded, "no".

When asked by Chairman Beauregard as to how the event co-coordinators billed the event, Mr. Hart responded, the promoter wanted to either promote a clothing line and he had music, and that was it; we gave it a shot, he was told, if there were no issues, maybe we would do it again, if there were issues, it wouldn't be allowed again.

When asked by Chairman Beauregard if he was familiar with the regulations regarding promoted events, Mr. Hart responded that he was not familiar with that regulation.

Chairman Beauregard stated that the city does not allow you to turn your place over to someone else to hold a promoted event.

When asked by Chairman Beauregard, so you currently have no alcohol in the facility right now, Mr. Hart responded, no, the bar has been closed for the past 3 or 4 years; adding, there's no alcohol on the premises.

When asked by Chairman Beauregard, so how do you provide alcohol for the banquet hall when you rent it out, Mr. Hart responded, we don't, they want us to supply the alcohol but we can't as of right now.

Chairman Beauregard responded, why not, you have a license?

Mr. Hart responded, but we don't provide it yet ... we're trying to get a bar manager ... I don't want to be responsible for the liquor ... I want someone else to be responsible for the liquor ... so I don't want to do that right now ... we want to hire somebody who is experienced ... I never worked with alcohol.

Chairman Beauregard responded, but that's why you're before us this evening, to which Mr. Hart responded, but I've never run a bar before, so we want to get a bar manager to run the bar ... we need to open the bar ... which we have not opened yet.

Chairman Beauregard informed Mr. Hart, you're before the Liquor Licensing Board here tonight, if we approve you, you're ultimately it.

Mr. Hart responded, I want to get approved but I want to get someone with experience to run the bar, so they can teach me so I can get certified, that's what we're trying to do.

Chairman Beauregard responded, you're here before us tonight for approval to be the manager of the liquor license ... are you anticipating that when you find that person ... they will become the manager ... you're not here tonight to be the manager of two hundred rooms ... you're here tonight to be the manager of the liquor license ... that's why you're here before us.

Mr. Hart responded, that's correct ... but I'm trying to get someone to help me out ... If I can't ... then they'll be the manager for the liquor.

Chairman Beauregard responded, but we're here tonight to approve you, to which Mr. Hart responded, right but I'm not certified yet ... I'm trying to get certified.

Chairman Beauregard responded, but that's easy enough to do ... but if you don't have the experience to run function halls ... then what would behoove us to approve you here tonight?

Chairman Beauregard continued remarks by stating, I know you may have the experience run to 200 rooms ... I get that ... but if you don't have the experience to run the bar and the functions halls ... but it would look pretty poorly on us to approve you as the manager ... if you do not have the experience to manage a facility of that size ... ultimately, you're the guy that is in charge of the liquor license ... if you don't have the experience ... then how can we approve you.

Mr. Hart responded, the only way I can rectify that is for them to get someone with experience to be the manager of the whole thing ... I do not have any experience to run a bar right now ... so I guess at this point I am not qualified to run the bar.

Commissioner Almeida stated that he agreed with Chairman Beauregard's position that Mr. Hart did not have the experience in the service of alcohol, therefore, he was not qualified to be the manager of the facility in regards to the service and sale of alcohol; and that Mr. Hart may certainly be the general manager of the facility just not the manager on the liquor license.

<u>Voted</u>:. Commissioner Almeida stated that based on the Board's opinion that Mr. Hart was not currently qualified nor had the experience to be the manager of a facility that includes both a bar area and a function hall, *made a motion to deny the approval of the application as presented; which was voted upon unanimously*.

The Licensee has the right to appeal this decision to the Alcoholic Beverages Control Commission under the provisions of M.G. L. Ch. 138 within five (5) days of receipt of this decision. A copy of said appeal must be submitted to this office as well.

After the vote, Mr. Nanopoulos raised his concern to the Board that Mr. Hart stated earlier in his testimony that they have not had alcohol on the premises for about 3 or 4 years, and that without an approved manager in place, it would be his recommendation to the Board that the liquor license be returned to the office, until such a time as a new manager is approved.

<u>ACTION TAKEN:</u> Chairman Beauregard agreed with Mr. Nanopoulos's assessment of the current status of the liquor license, and instructed Mr. Hart to bring in the liquor license, where it would be held until a new manager is approved by the Licensing Board and the Alcoholic Beverages Control Commission; and also reminded Mr. Hart, that while the liquor license is in our possession alcohol may not be stored, served, sold or consumed on the premises; and at no time, is alcohol allowed to be brought onto the premises by your guests.

## 6. PETITION - Trans. #00149-RS-0778- Plot # 47--38 & 47--39

Cork County, Inc. d/b/a Slainte Irish Pub & Grille, Barry M. Flynn, Co-Director, located at 34 Union Street, who is requesting permission to Change the Description of the Common Victualler (Restaurant) All Alcoholic Beverages licensed premises to include an additional room with a service bar that is contiguous to the licensed premise. The additional room, which is approximately 1872 sq. ft., is located on the first floor of the adjacent three story building and is numbered 44 Union Street, will have a direct entrance/exit into 34 Union Street; and will be used as a function hall and for additional dining. The licensed premise shall now be numbered 34-44 Union Street.

Final approval will require a 'Change of Tenant' from the Building Department.

# Present: Barry M. Flynn, Owner

Responding to questions from Chairman Beauregard, Mr. Flynn stated that he purchased the adjacent building, and that he was petitioning the Board to once again add the side room in that building, which is contiguous to the existing area at 34 Union Street; and added, that the area being requested was once on his license but then taken off when he was renting the space from the previous owner on that property numbered 44 Union Street. Mr. Flynn stated that there would not be any changes to the additional room as it was set up before, and that it would be used as a small function house.

When asked by Chairman Beauregard if the area was handicapped accessible, Mr. Flynn stated that he had an appeal pending before the ADA in Boston for relief regarding that issue.

<u>Voted:</u> On a motion by Commissioner Almeida, the Board **voted unanimously to approve the petition as presented**, and to forward the application to the Alcoholic Beverages Control Commission for their approval; with the following stipulation:

That the requested area, an <u>additional room</u> which is approximately 1872 sq. ft., and is located on the first floor of the adjacent three story building and is numbered 44 Union Street, which will have a direct entrance/exit into 34 Union Street; and will be used as a function hall and for additional dining, will not be used until such a time that the ABCC approves the application and the Commissioner of Buildings issues a Certificate of Occupancy; as well as receiving a sign off from the Health Department.

# 7. PETITION - Trans. #00137-RS-0778 - Plot # 50--34

JAKIBRI, LLC d/b/a Kirby's Irish Pub, Jason Kirby, Co-Manager of LLC, who is petitioning to Transfer a Common Victualler (Restaurant) All Alcoholic Beverages License to Ground Breakers, LLC d/b/a Doug's Sports Lounge. Upon approval, Douglas Grace will be the Sole Member, Sole Manager, and Sole-Interest Holder (100 %) of the LLC; and Douglas Grace is also the Proposed Manager of the Liquor License. The premises consists of one (1) room on the first floor of a street level building, which includes a bar area, with a 5' X 12' stage area, two (2) restrooms, and an office/storage room; all within an area approximately 1,409 sq. ft. Certified but he has a class set up to be held at his house for himself and 5 other employees ... and he has 3 other people that already certified.

When asked by Chairman Beauregard as to what type of entertainment he was planning on having, Mr. Grace responded,

Karaoke and some small bands on the weekends ... maybe a DJ.

When asked by Chairman Beauregard if he had any experience in the service of alcohol, Mr. Grace responded, "me, no".

When asked by Commissioner Almeida as to what type of music (Hip Hop) he would be offering, Mr. Grace laughed, and stated

No, I'm old school, to which Commissioner Almeida responded, you have to be careful because you have neighbors there.

<u>Voted:</u> On a motion by Commissioner Almeida, the Board **voted unanimously to approve the petition as presented**, and to forward the application to the Alcoholic Beverages Control Commission for their approval; with the stipulation that Mr. Grace submit a copy of his T.I.P.S. Certification to the Licensing Board office within thirty (30) days of receiving final approval or prior; and that all his servers be 'certified' as well, with copies of their certifications to be kept on file for review, if needed.

Mr. Patel owns three other liquor establishments in the Commonwealth of Massachusetts ... two in Brockton ... one in Rosendale ... he owns one all alcohol license ... and two beer and wine licenses ... he's owned EZ Convenience (sic) (Quick Stop Convenience?) for a number of years and he's looking to expand upon his business operation in the New Bedford area ... he's T.I.P.S. Certified ... his daughter is going through the T.I.P.S. Certification process as we speak ... she will be the manager ... so they're petitioning the Board for a beer and wine license only ... and we checked with the ABCC and they have no problem issuing another license to Mr. Patel ... you can have approximately five (5) licenses ... this will be his fourth ...

and he's basically in lockstep with what the Commonwealth is doing ... in that ... in the small convenience store ... gas station area ... in order to be competitive ... a lot of these stores are going for beer and wine licenses ... a lot of these stores are doing this throughout the Commonwealth ... so in the performance of his current business operations ...he's looking to expand that in the New Bedford area ... like I said, he's been in New Bedford many...many years ... he's never had an issue at any store ... he's never had an issue in his New Bedford store ... he is just looking to expand in the town and get a license for his New Bedford store.

Atty. Fingliss continued his presentation by stating, like I do with most of my other clients ... we basically had people

come in and sign a petition if they'd like to see another liquor license in the area ... and they have several hundred people that are in support of the beer and wine only license (the petition was not presented to the Board nor was it entered into the record, except for the statement that was made by Atty. Fingliss) ... and he's basically requesting that you issue the beer and wine only license to him.

Atty. Fingliss concluded his remarks by stating Ekta is not T.I.P.S. Certified ... although he (Suresh) is T.I.P.S. Certified ... but she is going through the process ... and like the Board has done in the past ... they grant the license subject to each and every employee who's going to be handling the beer and wine be T.I.P.S. Certified ... we have no problem with that ... we want to comply and conform with any and all directives from the Board.

Chairman Beauregard opened up his questioning by confirming with Atty. Fingliss that this would be his fourth license, and that he currently has two other (RPS) beer and wine licenses, and one (RPS) all alcohol license; to which Atty. Fingliss added, this is what he does for a living; adding that he's committed ... in the process of doing 40 to 50 thousand dollars of in betterment to the facility ... coolers ... everything ... he's got professional people involved as he does with his other stores to make this like his other establishments ... they're a very professional ... clean ... concise operation.

When asked by Chairman Beauregard if he was familiar with the fact that the license, if it is to be granted, is based on public need in that particular area, to which Atty. Fingliss responded, "that's correct".

When asked by Chairman Beauregard if he was aware that there are 4 or 5 other liquor establishments (<u>4</u> Off Premise) located in that area that are all located within a mile of that establishment; to which Atty. Fingliss responded, I understand that there are establishments that have full liquor licenses ... restaurants.

Chairman Beauregard interjected, just (RPS) ... you have Finest Liquors ... Towne Liquors ... Trio Liquors ... and Hi Lo Gas ... that are all located within a mile of his establishment; to which Atty. Fingliss responded, yeah ... that's four licenses ... I'm familiar with the law as Mr. Beauregard and I have discussed ... and four is definitely within the realm of possibility in obtaining a beer and wine license.

Chairman Beauregard responded, I not sure there's a regulation that states whether it's 2 ... 3 ... 4 as it relates to a certain number in an area.

Atty. Fingliss responded, I understand ... but in the case that we had litigated up in Boston ... it was five licenses that they were fully in acceptance of ... which I cited in my stuff ... so this would be like a fifth license in the area.

Chairman Beauregard responded, Town Liquors (Acushnet) ... which is not ours ... is only less than 500 ft. (466 ft.) away. Atty. Fingliss responded, that's Acushnet ... I understand ... but that's a full liquor license ... which is on the corner in Acushnet ... but he's only looking for a beer and wine license ... as the country and as these states are going this way ... if you go down to Florida ... Public Markets ... Stop & Shop's ... and other stores like that offer beer and wine everywhere ... this is basically a main staple for these guys to stay competitive within the area and to generate tax revenue and tax income for the City of New Bedford ... by just offering beer and wine ... he's not seeking a full liquor license ... that's not his intent.

This concluded Atty. Fingliss' presentation and Chairman Beauregard's questions for the applicant.

Chairman Beauregard then asked if any other Board Members had any questions for the applicant or Atty. Fingliss, seeing no further questions from the Board, upon hearing and seeing none, Chairman Beauregard called for a motion on the petition.

#### Violations: Massachusetts General Laws Chapter 138, sections 34, 34b, 34c, 64-

It is illegal for anyone under the age of twenty-one years to purchase or be in possession of an alcoholic beverage; identification must be checked on the day of service; The licensing authorities, after notice to the licensee and a reasonable opportunity to be heard, may modify, suspend, revoke or cancel said license upon satisfactory proof that the licensee has violated or permitted any condition thereof (Chapter 138), or any law of the commonwealth.

## ABCC Regulation 204 CMR 2.05: (2)-

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises.

#### Licensing Board Regulation No. 5, 10, 11-

Sale of alcoholic beverages, wine and malt beverages to persons under twenty-one years of age is prohibited; Alcoholic Beverages shall not be served to a person who is or appears to be intoxicated; Objectionable persons shall not be permitted on or about the premises, and it is the responsibility of the Licensee to enforce this rule.

## **Summary of Incident Reports**

Police Department Incident Report states that Officers were dispatched to 78 Covell Street regarding underage parties consuming alcohol at the bar. Upon entering the premises, the Officers observed a young female standing at the bar with several empty shot glasses along with two glasses in front of her. When the Officers approached her and asked her for an I.D., she became agitated and stated, "I don't have an I.D." # Massachusetts General Laws Chapter 138, sections 34, 34b, 34c, 64-

It is illegal for anyone under the age of twenty-one years to purchase or be in possession of an alcoholic beverage; identification must be checked on the day of service; The licensing authorities, after notice to the licensee and a reasonable opportunity to be heard, may modify, suspend, revoke or cancel said license upon satisfactory proof that the licensee has violated or permitted any condition thereof (Chapter 138), or any law of the commonwealth.

#### ABCC Regulation 204 CMR 2.05: (2)-

States no licensee shall permit any illegality to occur on the licensed premises. The licensee is responsible, whether present or not, for ensuring that no disorder, disturbance, or illegality takes place in, or on a licensed premises.

## Licensing Board Regulation No. 5, 10, 11-
