Report of the Acting Administrative Assistant to the Board

Ms. Davis gave the following report to the Board:

- -The values for Real Estate and Personal Property have been finalized.
- The LA3, which is the sales, is the first thing to be submitted to Gateway.
- Single family homes went up approximately 20% overall, this includes new homes that were not on the roll last year.
- -Last year the values were at approximately \$7,300,000,000 and this year we are at approximately \$8,600,000,000.

- --We are still waiting to hear from the state if we will receive reimbursement for our FY22 Statutory Exemptions.
- -The classification hearing was supposed to be held around November 14, 2022, however, due to accounting delays the classification hearing has been pushed to December 6, 2022.
- -The bills will be printed in house and this date still allows enough time to get the bills out on time.
- -The last two days have been spent editing entries in AssessPro to remove all punctuation for the macro for Gateway.
