Proactive Targeted Ground Spraying Planned for New Bedford

New Bedford, Massachusetts- The Bristol County Mosquito Control Project will conduct targeted ground spraying early on the morning of Thursday, August 6, 2015. This round of spraying will target areas including Buttonwood Park, Brooklawn Park, Fort Taber, Hazelwood Park, Riverside Park, Clasky Park, Ashley Park and the Poor Farm area. Spraying will take place between 2:00 am and sunrise on Thursday morning, weather permitting. <u>Residents in the vicinity of the targeted areas may wish to close their windows on Wednesday evening prior to the spraying.</u>

The Bristol County Mosquito Control Project has been conducting surveillance in our area to track the potential for EEE and WNV carrying mosquitoes. Mosquito traps are in place to collect additional pools of mosquitoes and monitoring of mosquito populations will be on-going to assess the effectiveness of the spraying effort.

The following precautions are advised:

Avoid Mosquito Bites

- Be Aware of Peak Mosquito Hours While mosquitoes are out at all hours of the day, their peak biting times are from dusk to dawn. Consider rescheduling outdoor activities that occur during evening or early morning. Otherwise, take extra care to use repellent and protective clothing, especially if you work or spend a lot of time outdoors.
- Clothing Can Help Reduce Mosquito Bites. Although it may be difficult to do when it's hot, wearing long-sleeves, long pants and socks when outdoors will help keep mosquitoes away from your skin.

Apply Insect Repellent when you go outdoors. Use a repellent with DEET (N, N-diethyl-m-toluamide), permethrin, picaridin (KBR 3023), IR3535 or oil of lemon eucalyptus [p-methane 3, 8-diol (PMD)] according to the instructions on the product label. DEET products should not be used on infants under two months of age and should be used in concentrations of 30% or less on older children. Oil of lemon eucalyptus should not be used on children under three years of age. Permethrin products are intended for use on items such as clothing, shoes, bed nets and camping gear and should not be applied to skin.

Mosquito-Proof Your Home

- Drain Standing Water Mosquitoes lay their eggs in standing water. Limit the number of places around your home for mosquitoes to breed by either draining or getting rid of items that hold water. Check rain gutters and drains. Empty any unused flowerpots and wading pools, and change water in birdbaths frequently.
- Install or Repair Screens Some mosquitoes like to come indoors. Keep them outside by having tightly-fitting screens on all of your windows and doors.
