The intersection falls within the MASS DOT Railroad Right of Way adjacent to Map 125, Lots 113 & 29 and Map

123 Lot 109. Wetland replication also falls within MASS DOT Railroad property (Map 102, Lot 78). Applicant proposes to reconstruct the Tarkiln Hill Road and Kings Highway intersection and provide associated drainage improvements and wetland replication. Representative is David Fredette, City Engineer.

5. **SE49-0805** – (Continued from 6/19/18) A Notice of Intent as filed by the Jean Fox of the Massachusetts Department of Transportation for property identified as the Right of Way of the Railroad Main Line in New Bedford extending from the Freetown Municipal Boundary to the intersection of Hillman St. and McArthur Dr. and including the Whales Tooth Parking Lot. Applicant proposes to conduct track improvements, grade crossing improvements, track drainage, installing signals and communication systems. In addition the Whales Tooth Train Station will be constructed which will include new platforms, track improvements, parking facilities and storm water drainage. Impacts are proposed to Bank, Bordering Vegetated Wetland, Bordering Land Subject to Flooding, Land Subject to Coastal Storm Flowage, Land Under Water and Riverfront Area. Representative is Carlson Lars of VHB.
