Re: <u>Unlicensed/Unpermitted Dock off Washburn Street, New Bedford</u>

Dear Attorney Badwey:

Reference is made to my letter to you dated August 30, 2016 and your reply letter to me dated September 7, 2016 regarding the above described matter.

On November 1, 2016, MassDOT Senior Counsel Eileen M. Fenton sent you a letter regarding the unlicensed and unpermitted dock located within the State Highway Layout between Route I-195 and Washburn Street along the Acushnet River in New Bedford, confirming your clients' voluntary agreement to remove said dock no later than November 30, 2016 as noted in your September 7<sup>th</sup> letter.

In the event your clients anticipate constructing a dock or other structure in the future in another location, it is important that they are aware of the permitting and licensing requirements associated with such activity under Massachusetts law, including but not necessarily limited to the Massachusetts Public Waterfront Act, M.G.L. c. 91, and the Massachusetts Wetlands Protection Act, M.G.L. c. 131, §40.

Pursuant to M.G.L. c. 91 and 310 CMR 9.03(1) promulgated pursuant thereto, written authorization in the form of a license, permit, or amendment thereto must be obtained from the Department of Environmental Protection before the commencement of one or more activities specified in 310 CMR 9.03(2) and (3) or 310 CMR 9.05 and located in one or more geographic areas specified in 310 CMR 9.04, unless the legislature has specifically exempted any such activity from Department jurisdiction under M.G.L. c. 91.

In addition, projects that are constructed within Chapter 91 geographic jurisdiction often are subject to review and permitting under the Massachusetts Wetlands Protection Act. Pursuant to 310 CMR 10.02(2)(a), any activity proposed or undertaken within an area specified in 310

CMR 10.02(1) which will remove, fill, dredge or alter that area is subject to regulation under M.G.L. c. 131, §40 and requires the filing of a Notice of Intent with the local Conservation Commission; no person shall remove, fill, dredge or alter any jurisdictional wetland resource area without receiving and complying with a final Order of Conditions.
