1. SE49-0728 - (Continued from 1/5/16, 1/19/16, 2/2/16) - A Notice of Intent as filed by Parallel Products for property identified as 50 Duchaine Boulevard (Map 134, Lots 456, 457, 458, and 459). Applicant proposes to conduct site improvements to existing developed site, including additional parking and additional trailer loading services. Work is proposed within the Buffer Zone to Bordering Vegetated Wetlands. Representative is John Marchand of Thompson Farland, Inc.
2. SE49-0729 – (Continued from 1/19/16, 2/2/16) - A Notice of Intent as filed by Erick D’Leon, Airport Manager, of the City of New Bedford Regional Airport for property identified as 1569 Airport Road (Map 123 – Lot 3; Map 124 - Lots 14, 28, 82 & 113; Map 125 – Lot 22 and Map 128 – Lot 32).
