Annual Beach Grooming

Maintenance Plan for (Map 012 - Lots 215, 216, 264)

March/ April

- Remove shells accumulated from winter wave activity from beach between Mean High Water (MHW) mark and beginning of coastal bank vegetation line.

May 1st – July 30th

- No mechanical work, maintenance, disturbance, etc. for 'wildlife protection season' most notably Horseshoe Crab (*Limulus polyphemus*) that lays eggs and hatch near the High Water Mark, under Full and New moon spring tide conditions.
