AGENT UPDATES/GENERAL CORRESPONDECE

1. SASSAQUIN POND SAMPLING

Agent Perks stated that on Jan 2 SMAST will be taking samples from Sassaquin Pond, which includes 5 gallons of mud for testing and used as part of the MicroLift efficacy study that will be done in a controlled lab setting in conjunction with UMass Dartmouth, Coastal Systems Science Lab.

Mr. Jeff Young of AMT Bioproducts Corp. was present for explanation of the testing and gave a brief summary of the use of bacteria that was going to be used in the testing.

Chairman Audette required to see the report of the findings from the study before the discussion for extension of Order of Conditions as stated in the Special Conditions.

2. BUTTONWOOD BROOK PROJECT KICKOFF

DPI would like to remove tree stumps, fill, and level off areas of the existing work zone permitted under file #SE049-0844.
