NEW HEARINGS:

SE049-0883 - A Notice of Intent as filed by the City of New Bedford Public
Infrastructure for property identified as WS Sassaquin Ave, New Bedford, Ma
(Map 138, Lot 438). The City of New Bedford is proposing the following water quality
improvements at Sassaquin Pond in New Bedford: Alum Treatment, Common Reed
(Phragmites Australis) removal and management, and impervious area removal.
Representative is Magdalena Lofstedt of CDM Smith Inc.

Shawn Syde, Engineer for the City of New Bedford, present along with Zach Eichenwald and Danielle Gallant from CDM Smith. Mr. Syde stated that they are here to file a *Notice of Intent* for three different types of projects that will be done at Sassaquin Pond for an *Order of Conditions*. Mr. Syde began with a brief description of how the City of New Bedford has been trying to improve water quality since the 1970's. In 2020 the City of New Bedford began to appropriate money and continued to install devices such as a Jelly Fish Unit that are used to remove phosphorus from storm water that gets discharged into the pond. The City wanted a better way of doing this, since using these units are expensive to maintain and repair. The City along with council members and the administration decided to step back and take a holistic review and develop a new way to improve water quality in both short and long term. September 2021 New Bedford Department of Public Infrastructure and Sassaquin Pond Betterment Alliance developed a watershed-based management approach to address water quality called *The Watershed Management Plan (WMP)* which is located on the city website.

The plan consists of 3 projects: Alum Treatment, Phragmites Removal, and Limited Impervious Area Removal.

- 1. <u>Alum Treatment:</u> Reduce internal phosphorus release, liquid aluminum sulfate and liquid sodium aluminate using a boat equipped with a calibrated pumping injection system, applied during spring when algae concentrations are lower, treating 22 acres of pond, monitoring before, during, and after treatment.
- 2. <u>Phragmites Removal and Management:</u> Clearcast systemic herbicide by foliar treatment for 2 consecutive years, selectively applied using low volume backpack sprayer, Labor Day-Mid October, cut stalks after 1st year of treatment, repeat treatment 2nd year, follow up monitoring and hand cut removal by DPI.
- 3. <u>Impervious Area Removal</u>: Remove two asphalt drainage swales and replace with naturalized bioswales, plant with sedges, Buttonbush, and Inkberry, reduce velocity of stormwater runoff into the pond and improve water quality, remove 1,000sf of old paved roadway, restore to grassy field, reduce velocity of stormwater runoff into the pond and improve water quality and provide groundwater recharge.

Mr. David Costa of 1333 Sassaquin Ave.asked how the treatment will be applied, probability of this working, and where is the money coming from? Mr. Syde stated that treatment would be done on a boat and applied directly above the water and the treatment will likely reduce the algae of reproducing. Stormwater is still a source of Phosphorus, but the project will help as the chemicals will continue to work on the bottom of the pond to eliminate the algae. The City has a \$1.5million Bond for the whole project.



Mr. Mike Frey of 1479 Morton Ave. stated he is in favor of the project.

Agent Perks read in a letter from Councilor At Large Linda Morad dated 2/15/22 in support of an NOI. (See attached letter).

Agent Perks recommends the commission add a condition that he be notified and brought on scene when the work is being conducted so he can better relay updates to the commission. Agent Perks recommends the issuance of an *Order of Conditions* with the *Standard Inland Special Conditions* as well as a condition as requested by Councilor Morad about a copy of the pesticides permit be sent to the Conservation office by August 2022 and to also notify the commission should there be any delays in the work in 2022.

Mr. Syde informed Agent Perks that the project is a 2 year project and he would let Councilor Morad know this, since the project will continue past the deadline she gave of the end of the calendar year 2022.

He then saw a gentleman knocking down big pine trees on the edge of the solar field. He asked the gentleman to stop cutting the trees and asked who he worked for. At that time Agent Perks was shown a map of the trees that he needed to cut down. At the same time, Agent Perks could see 6 trees that already had been cut. Once back in the office, Agent Perks looked up the area and it appeared that it might fall in the Town of Dartmouth. Agent Perks reached out to the Town of Dartmouth Conservation Department and had a meeting with them. They are taking this very seriously. By issuing a violation it will allow the Agents to enter the property to assess the damage. Agent Perks will keep the commission posted with more details as they become available. Dartmouth will be taking the lead on this.

Notice of Intent as filed by the City of New Bedford Public Infrastructure for property identified as WS Sassaquin Avenue, New Bedford (Map 138, Lot438)

Dear Chairman Audette and Members of the Conservation Commission:

I am writing in reference to the above-referenced request which is to be heard by the Conservation Commission on Tuesday, February 15, 2022. Unfortunately, I am not able to attend the meeting due to a prior commitment scheduled for the same date and time. I would however like to offer my support for, and comments related to this Notice of Intent regarding several projects proposed for Sassaquin Pond.

While I strongly support the petitioner's request that will begin a series of long overdue projects to improve the water quality in Sassaquin Pond, I want to be sure that once approved by the Conservation Commission that there are no further delays in completing the three phases of this work covered by this Notice of Intent. It is my understanding that this work is to be completed in 2022; therefore, I would like the Conservation Commission to condition the approval of this application in a manner that requires the petitioner to report any delays that would affect the completion of the three phases of this project by the end of the calendar year.

Further, there is a state license that will need to be obtained by the contractor, Solitude Lake Management, who will be completing the phragmites removal phase of this project from the MASS Department of Environmental Protection. I am requesting that the Conservation Commission require that said license be presented to the Commission no later than August 01, 2022 to ensure that this phase of the project can be completed in early fall.

Thank you in advance for your attention to this correspondence. Kindly read this letter into the record of the Conservation Commission meeting to make those in attendance and the general public aware of my support and concerns for the proposed Notice of Intent.
