Dear Agent Perks and the Members of the Commission:

On behalf of Eversource Energy Service Company (Eversource), Tighe & Bond respectfully requests the issuance of a Certificate of Compliance (COC) related to the New Bedford Oceanarium Project. The Order of Conditions (OOC; Registry of Deeds book 5524 and page 262) was issued by the New Bedford Conservation Commission (the Commission) to New Bedford Oceanarium Corporation on May 20, 2002, for activities within the Canon Street Station property, located at 180 MacArthur Drive in New Bedford, Massachusetts, at the time owned by Commonwealth Electric. Eversource is selling the property, and the title exam uncovered this open OOC. A copy of WPA Form 8A Request for Certificate of Compliance is provided in Attachment A, and a copy of the OOC is provided in Attachment B.

Project Background

The proposed project consisted of renovating a former power plant building located on-site to house an oceanarium, which would have included aquarium tanks, exhibits, educational facilities, exhibition halls, offices, meeting rooms, and other amenities. However, the work was never initiated. No component of the proposed project was undertaken at the subject property.

Regulatory Compliance

The original OOC was issued on May 20, 2002 and was recorded at the Bristol County Registry of Deeds on the same day in Book 5524, Page 262. As noted above, no proposed aspects of this project were ever undertaken. A record search was conducted by Eversource on March 24, 2022, to review any available documents pertaining to this project in the Commission's records. No Registered Professional Engineer-stamped plans were located in the available files. As the work was never undertaken, it is our understanding that record drawings will not be required. In accordance with 310 CMR 10.05(9)(b), a site inspection took place on April 5, 2022, by the New Bedford Conservation Commission, Tighe & Bond, and Eversource to confirm OOC compliance. A letter from a Registered Professional Engineer certifying that the proposed work was not undertaken is provided in Attachment C.

Summary

The original OOC and the Request for Certificate of Compliance Application (WPA Form 8A) are enclosed. A check for \$1,500 will be submitted to the New Bedford Conservation Commission under separate cover. We appreciate your review of this request and supporting materials at your next scheduled public hearing on May 3, 2022. B. Findings (cont.)

- 4. The work authorized hereunder shall be completed within three years from the date of this Order unless either of the following apply:
 - a. the work is a maintenance dredging project as provided for in the Act; or
 - b. the time for completion has been extended to a specified date more than three years, but less than five years, from the date of issuance. If this Order is intended to be valid for more than three years, the extension date and the special circumstances warranting the extended time period are set forth as a special condition in this Order.
- 5. This Order may be extended by the Issuing authority for one or more periods of up to three years each upon application to the issuing authority at least 30 days prior to the expiration date of the Order.
- Any fill used in connection with this project shall be clean fill. Any fill shall contain no trash, refuse, rubbish, or debris, including but not limited to lumber, bricks, plaster, wire, lath, paper, cardboard, pipe, tires, ashes, refrigerators, motor vehicles, or parts of any of the foregoing.
- 7. This Order is not final until all administrative appeal periods from this Order have elapsed, or if such an appeal has been taken, until all proceedings before the Department have been completed.
- 8. No work shall be undertaken until the Order has become final and then has been recorded in the Registry of Deeds or the Land Court for the district in which the land is located, within the chain of title of the affected property. In the case of recorded land, the Final Order shall also be noted in the Registry's Grantor Index under the name of the owner of the land upon which the proposed work is to be done. In the case of the registered land, the Final Order shall also be noted on the Land Court Certificate of Title of the owner of the land upon which the proposed work is done. The recording information shall be submitted to this Conservation Commission on the form at the end of this Order, which form must be stamped by the Registry of Deeds, prior to the commencement of work.
- A sign shall be displayed at the site not less then two square feet or more than three square feet in size bearing the words.

"Massachusetts Department of Environmental Protection" [or, "MA DEP"]

- 10. Where the Department of Environmental Protection is requested to issue a Superseding Order, the Conservation Commission shall be a party to all agency proceedings and hearings before DEP.
- 11. Upon completion of the work described herein, the applicant shall submit a Request for Certificate of Compliance (WPA Form 8A) to the Conservation Commission.
- 12. The work shall conform to the plans and special conditions referenced in this order.
- 13. Any change to the plans Identified in Condition #12 above shall require the applicant to inquire of the Conservation Commission in writing whether the change is significant enough to require the filing of a new Notice of Intent.
- 14. The Agent or members of the Conservation Commission and the Department of Environmental Protection shall have the right to enter and inspect the area subject to this Order at reasonable hours to evaluate compliance with the conditions stated in this Order, and may require the submittal of any data deemed necessary by the Conservation Commission or Department for that evaluation.

- 15. This Order of Conditions shall apply to any successor in interest or successor in control of the property subject to this Order and to any contractor or other person performing work conditioned by this Order.
- 16. Prior to the start of work, and if the project involves work adjacent to a Bordening Vegetated Wetland, the boundary of the wetland in the vicinity of the proposed work area shall be marked by wooden stakes or flagging. Once in place, the wetland boundary markers shall be maintained until a Certificate of Compliance has been issued by the Conservation Commission.

17. All sedimentation barriers shall be maintained in good repair until all disturbed areas have been fully

stabilized with vegetation or other means. At no time shall sediments be deposited in a wetland or water body. During construction, the applicant or his/her designee shall inspect the erosion controls on a daily basis and shall remove accumulated sediments as needed. The applicant shall Immediately control any erosion problems that occur at the site and shall also immediately notify the Conservation Commission, which reserves the right to require additional erosion and/or damage prevention controls it may deem necessary. Sedimentation barriers shall serve as the limit of work unless another limit of work line has been approved by this Order. C. Appeals

The applicant, the owner, any person aggrieved by this Order, any owner of land abutting the land subject to this Order, or any ten residents of the city or town in which such land is located, are hereby notified of their right to request the appropriate DEP Regional Office to issue a Superseding Order of Conditions. The request must be made by certified mail or hand delivery to the Department, with the appropriate filing fee and a completed Appendix E: Request of Departmental Action Fee Transmittal Form, as provided in 310 CMR 10.03(7) within ten business days from the date of issuance of this Order. A copy of the request shall at the same time be sent by certified mail or hand delivery to the Conservation Commission and to the applicant, if he/she is not the appellant.

The request shall state clearly and concisely the objections to the Order which is being appealed and how the Order does not contribute to the protection of the interests identified in the Massachusetts Wetlands Protection Act, (M.G.L. c. 131, § 40) and is inconsistent with the wetlands regulations (310 CMR 10.00). To the extent that the Order is based on a municipal ordinance or bylaw, and not on the Massachusetts Wetlands Protection Act or regulations, the Department has no appellate jurisdiction.

D. Recording Information

New Redford

This Order of Conditions must be recorded in the Registry of Deeds or the Land Court for the district in which the land is located, within the chain of title of the affected property. In the case of recorded land, the Final Order shall also be noted in the Registry's Grantor Index under the name of the owner of the land subject to the Order. In the case of registered land, this Order shall also be noted on the Land Court Certificate of Title of the owner of the land subject to the Order of Conditions. The recording information on Page 7 of Form 5 shall be submitted to the Conservation Commission listed below.

- 18. No activity shall occur prior to obtaining all necessary and required permits, licenses, and approvals; and until copies of the same have been furnished to the Conservation Commission.
- 19. Any design modifications, alterations, amendments, or additions shall be subject to the approval of the New Bedford Conservation Commission. Requests for any changes shall be made in writing and shall be accompanied by a revised plan.
- 20. No modification to surface features, drainage or topography shall be permitted except as indicated by this Order of Conditions.
- 21. Contours shall remain unchanged except as permitted by this Order of Conditions.
- 22. There shall be no construction other than that proposed by the Notice of Intent and included on the submitted plan.
- 23. Immediately upon completion of the exterior construction and grading, permanent stabilization landscaping shall be carried out in order to minimize erosion.
- All wet areas not to be altered shall be kept clear of rubbish, debris, and construction material.
- 25. All exposed soil or subsoil shall be replanted with vegetation such as grass, groundcover or shrubs so as to minimize erosion and siltation.
- 26. There shall be minimum disruption of existing grades and vegetation in order to minimize erosion
- No runoff shall be caused to drain on to adjoining property or on any public ways.
- 28. All excess material shall be removed from the site.
- 29. The owners shall notify the Conservation Commission of the work-start date prior to its commencement so that regular inspections may be made.
- 30. All work performed in accordance with said plans and this Order of Conditions shall be in compliance with the state building and/or plumbing code.

- 31. The Inspector and/or the Commission members shall have the right to enter upon the land for the purpose of the inspection and/or the taking of pictures to determine and evaluate compliance with this order.
- 32. The design engineer will certify, in writing, that this project has been complete in accordance with the above Order of Conditions before the Certificate of Compliance will be issued.
- 33. All facilities and equipment shall be continually operated and maintained so as to comply with this order of conditions and M.G.L. Ch. 131, S 40, the Wetlands Protection Act.
- 34. Certain conditions, such as maintenance or monitoring are on-going and are not to expire at the end of three years or with the issuance of a Certificate of Compliance.
- 35. This order of Conditions shall apply to any successor in interest or successor in control.
- 36. Any changes required by any other board or authority may require a new filing with the Conservation Commission.
- 37. At the discretion of the Conservation Commission, the applicant may be required to file with any or all of the following agencies:

The Department of Environmental Protection Army Corps of Engineers Coastal Zone Management Division of Waterways

- 38. The Conservation Commission and/or the City of New Bedford shall not be responsible or liable for the construction, the operation, or the maintenance of any part of this project and does not warrant the safety of the same.
- 39. Any fill and/or construction materials shall be placed in upland areas.
- 40. Any mitigation and resource protection devices and measures, e.g. hay bales, siltation fence, etc., are to be installed prior to initiation of any work under this Order of Conditions. The Conservation Agent shall be notified when in place for inspection and verification. No work to be undertaken under the Order of Conditions until written or verbal approval is received from the Conservation Commission or its Agent.
- 41. In accordance with Condition number thirteen (13), no activity shall take place until the applicant has furnished written documentation that the plans on file with the Conservation Commission are consistent with permits and approvals of other Town Boards.
- 42. Prior to any construction, an on-site inspection is to be held between the proposed contractor, the engineer, and the Conservation Commission Agent to

go over the sequence of construction and all other restrictions and requirements as noted on the Order of Conditions. A written construction schedule to be received at that time.

- 43. All erosion control barriers shall be constructed of snow fencing, silt fencing and staked hay bales and clearly depicted on the plans, and placement shall be inspected both pre and post construction by Agent
- 44. Any changes in proposed drainage patterns will require written approval by the Conservation Commission.
- 45. Wetland flagging to remain in place until the project has been completed and Certificate of Compliance issued.
- 46. Notice of Intent, Order of Conditions and plans shall be retained on the site during construction and made available to all contractors.
- 47. All conditions are on going and do not expire until the issuance of a Certificate of Compliance.
- 48. The design engineer will certify, with an as-built plan, that this project has been completed in accordance with the above Order of Conditions before the certificate of Compliance will be issued.

4.1 Recommended Maintenance Procedure

For the "disc" design, oil is removed through the 6" inspection/cleanout pipe and sediment is removed through the 24" diameter outlet riser pipe. Alternatively, oil could be removed from the 24" opening if water is removed from the treatment chamber, lowering the oil level below the drop pipes.

The depth of sediment can be measured from the surface of the Stormceptor with a dipstick tube equipped with a ball valve (Sludge Judge³). It is recommended that maintenance be performed once the sediment depth exceeds the guideline values provided in Table 3 for the reasons noted in Section 4 Stormceptor Maintenance Guidelines.

No entry into the unit is required for routine maintenance of the Inlet Stormceptor or the smaller disc insert models of the In-Line Stormceptor. Entry to the level of the disc insert may be required for servicing the larger disc insert models. Any potential obstructions at the inlet can be observed from the surface. The fiberglass insert has been designed as a platform for authorized maintenance personnel, in the event that an obstruction needs to be removed, sewer flushing needs to be performed, or camera surveys are required.

Typically, maintenance is performed by the Vacuum Service Industry, a well established sector of the service industry that cleans underground tanks, sewers, and catch-basins. Costs to clean a Stormceptor will vary based on the size of the unit and transportation distances. 


Figure 1 Single Inlet/Outlet "Disc" Insert In-Line Stormceptor




Figure 2 STC 450i Inlet Stormceptor

4.2 Disposal of Trapped Material from Stormceptor

The requirements for the disposal of material from Stormceptor are similar to that of any other Best Management Practices (BMP). Local guidelines should be consulted prior to disposal of the separator contents.

In most areas the sediment, once dewatered, can be disposed of in a sanitary landfill. It is not anticipated that the sediment would be classified as hazardous waste. In some areas, mixing the water with the sediment will create a slurry that can be discharged into a trunk sanitary sewer. In all disposal options, approval from the disposal facility operator/agency is required. Petroleum waste products collected in Stormceptor (oil/chemical/fuel spills) should be removed by a licensed waste management company.

What if I see an oil rainbow or sheen at the Stormceptor outlet?

With a steady influx of water with high concentrations of oil, a sheen may be noticeable at the Stormceptor outlet. This may occur because a rainbow or sheen can be seen at very small oil concentrations (< 10 ppm). Stormceptor will remove over 95% of all free oil and the appearance of a sheen at the outlet with high influent oil concentrations does not mean that the unit is not working to this level of removal. In addition, if the influent oil is emulsified, the Stormceptor will not be able to remove it. The Stormceptor is designed for free oil removal and not emulsified or dissolved oil conditions.

5.0 Recommended Safety Procedures

CSR strongly recommends that any person who enter a Stormceptor System follow all applicable OSHA regulations for entry and work in permit required confined spaces, as outlined in 29 CFR 1910.146. A permit required confined space consists of a space that:

- · Is large enough and so configured that an employee can bodily enter and perform assigned work.
- Has limited or restricted means for entry and exit.
- Is not designed for continuous employee occupancy.
- · Contains or has one of the following:
 - a potential to contain a hazardous atmosphere.
 - a material that has the potential for engulfing an entrant.
 - any other recognized serious safety hazard.

Storm water and wastewater systems fall under the OSHA guidelines for a permit required confined space. Failure to follow OSHA guidelines for entry and work in a permit required confined space can result in serious injury or death. Please exercise extreme caution and follow appropriate safety procedures when entering any confined space.

Two square pick holes in the cover vent the Stormceptor, allow for removal of the cover, and provide sampling ports for air quality monitoring before the cover is removed. If you must enter the Stormceptor, please note that if the disc insert inside is wet, it can be slippery.
