#### **CONTINUED HEARINGS:**

1. SE049-0867 - (Continue from 11/16/21, 12/7/21, 12/21/21, 1/4/22, 1/18/22, 2/1/22, 2/15/22,3/1/22,3/15,22,4/5/22,4/19/22,5/3/22,5/17/22,6/7/22) - A Request to Amend Order of Conditions as filed by Shoreline Resources, LLC for property identified as 10 & 26 N Front St (Map 79, Lot 2 & 5). The applicant is proposing to replace the existing 24-inch akron stormwater line with a new 24-inch PVC stormwater drain outside the limits of the travel lift area and continue to accommodate overflows from the City-owned stormwater system, property stormwater, and existing building roof run off within a coastal flood zone on the Shoreline Resources property, formerly Revere Copper. SE049-0892 – (Continued from 4/5/22,4/19/22,5/3/22,6/7/22) - A Notice of Intent as filed by Michael Quinn of Shoreline Marine Terminal, LLC. for property identified as 24 N Front St New Bedford, MA (Map 79, Lot 2 & 5). The applicant is proposing the partial demolition of building #2 and full demolition of building #12 within a coastal flood zone on the Shoreline Resources property, formerly Revere Copper. Representative is Lauren Gluck of Pare Corp. CONTINUED TO 7/5/22

3. A Request for a Determination of Applicability as filed by Ceasar Duarte for property identified as 40 Tichon Ave. New Bedford, MA (Map72, Lot 284 &294). The applicant is requesting a determination as to whether the site is within a Designated Port Area and requires further permitting as it exists currently. Representative is Susan Nilson of Foth Engineering.

Agent Perks noted that per the last hearing the applicant did not need to be present tonight. Agent Perks stated that he had been in contact with DEP and the applicant to discuss the right determination for both parties. It was determined a Negative Box 2 was the best suggestion for the applicant to proceed with permitting and also insure that the conservation commission would have further review on future projects. Agent perks recommends a Negative Box 2.

4. <u>SE049-0893</u> – (Continued from A Notice of Intent as filed by Mary Rapoza for property identified as East Rodney French Blvd. parking lots, New Bedford, MA (Map 4, Lots 100, 101, 102). The applicant is proposing to construct stormwater improvements in the three existing East Beach parking lots along East Rodney French Blvd. Representative is Jessica Wala of Nitsch Engineering. <u>CONTINUED TO 7/5/22</u>

### **NEW HEARINGS:**

1. <u>SE049-</u> - A Notice of Intent as filed by Calodesu, LLC. for property identified as Pequot Street New Bedford, Ma (Map 136A, Lots 886). The Applicant is proposing construction of a single-family house with associated grading and utilities in the 100ft buffer zone. Representative is Christopher Gilbert of Farland Corp, Inc.

Mr. Christopher Gilbert present tonight representing Calodesu, LLC. Mr. Gilbert gave a brief description of the demolition plan and the clean up of this project. Mr. Gilbert stated that 10 trees would be removed and the debris that was found on the property, which included tires, tubs, would be hauled out before the proposed construction. Agent Perks requested to confirm the locations of the wetland flags for this project and to make sure they were up to date and in place. Agent Perks comments of this project would then depend on the placement of the flags and delineation field sheets. Agent Perks inquired about the clearance underneath of the roof recharge system and if the Department of Public Infrastructure has reviewed the plans. Commissioner Linhart would like a condition to reference what type of pesticide and fertilizer that can be used. Vice-Chairman opened the floor for anyone that is opposed to this project. Russell Campoli, Rita Campoli, Rose Vieira and Matt Mckay all residents of Pequot Street voiced their concerns on this Project. They all feel that this will lead to more houses being developed and the destruction of the wetlands in their area.

2. A Request For Determination of Applicability as filed by Lars Vinjerud II of Harborview LLC, DBA Fleet Marina for property identified as 226 Popes Island, New Bedford, MA (Map 60, Lots 11). Applicant is proposing a flagpole installation in an area subject to coastal storm flowage. Representative is Deven Franco of Harborview LLC, DBA Fleet Marina. Mr. Michael Corscadden of Fleet Marina present tonight representing Lars Vinjerud. Mr. Corscadden stated they are proposing to install a 6'x 6', 4' deep flag pole and reason for this high pole would be so that the American flag would



be higher than all the other surrounding flags. The project would take about a day and a half to complete and all fill that is dug up would be removed immediately. Agent Perks requested to do a site visit to check the arosion controls prior to the start of the project and inquired about the special condition about concrete, which Mr. Corscadden stated they will have a dumpster. Agent Perks recommends a Negative Box 3 Determination.
