4. **SE049-0902** - (Continued from 7/5/22) - **A Notice of Intent as filed by Tim Cusson of Parallel Products Solar Energy for the property identified as 781 Church Street New Bedford, MA (Map 129 Lots 41).** The applicant is proposing construction of two solar canopies with concrete column foundations. Representative is Christian Farland of Farland Corp, Inc.



Nick Dufrense present tonight representing Tim Cusson, who is present along with Richard Frades. Mr. Dufrense stated that this was their third time in front of the Commission and spoke about the changes made that was requested at the last meeting. Mr. Dufrense stated that they do not have a plan in place for the debris barrier along the property and that a phase one assessment is not required for this project. Mr. Dufrense also noted that Mr. Frades had started cleanup of the property back in the spring which was paused during the summer and will commence once the conditions allow in the fall. Commissioners Grant and Linhart both questioned the soil being contaminated due to years of debris and tires being on the property and what is going to happen to the soil that is dug up to install the panels. Mr. Cusson stated that the extra soil will be spread out on the rest of the property and that there's no soil contamination found on the property. Commissioner Linhart stated that a special condition be added that Agent Perks be onsite to make sure the solar panels are not in the 25ft buffer before being finalized and plans on how the wetlands are going to be cleaned up and phased into the project. Chairman Audette stated that the plans still show that the solar panel still hangs over the 25ft buffer zone. Mr. Cusson was adamant that the plans do show the solar panel does not fall in the 25ft buffer and stated they have no problem making sure the panel does not hang over the 25ft buffer line. Chairman Audette stressed that they need to maintain the 25ft buffer line and signage be added to show where the line is on the property. Agent Perks recommends some type of barrier placed and signage to show the 25ft buffer line and recommends the Commission condition a yearly walkthrough due to debris being blown off site into the surrounding resource areas. Agent Perks is recommending an issuance of an *Order of Conditions* with the *standard inland special conditions* along with the special conditions of confirming that the solar panels do not cross over the 25ft buffer line, the debris clean up must happen prior to any construction and signage be hung along the western boarder noting the 25ft buffer line.

SE049-0904 - A Notice of Intent as filed by Andrew Bernstein of Kearsarge Energy Inc. for property identified as John Vertente Blvd, New Bedford, MA (Map 135, Lots 1, 3, 15, & 47).** The applicant is submitting an after-the-fact NOI for the tree clearing at a ground-mounted, photovoltaic solar array. Representative is Richard Rheume of Prime Engineering, Inc. **CONTINUED TO 8/16/22.**

Mr. Richard Rheume present tonight representing Andrew Bernstein. Mr. Rheume made note that the trees being planted were not the same species as the ones that were cut down but were approximately a one to one replacement. Agent Perks then stated that the *Certificate of Compliance* that was issued was just a partial *CoC* and a new plan is needed for finishing a successful planting as required. The Commission asked Mr.Rheume to provide a revised plan that depicts both the replacement planting for the replication areas as well as the replacement plantings for the trees felled in violation.

## **NEW HEARINGS:**

- 1. A Request For Determination of Applicability as filed by Jessica Shahdan of MA Department of Conservation and Recreation for property identified as 49 State Pier, New Bedford, MA (Map 47, Lot 203).** Applicant is proposing to replace five damaged fender piles and new fender system within land under the ocean resource area.



Representative is Jessica Shahdan of MA DCR.

Mr. Michael Driscoll, owner of the pier, present tonight along with Jessica Shahdan, manager of the pier, and both of the *Department of Conservation and Recreation* (DOR). Mr. Driscoll stated that the project consisted of replacing 5 damaged fender piles on the southwest corner of the state pier with 5 new ones. The intention is to removed the piles entirely so new ones can be placed in the same hole and turbidity curtains in place to catch any debris. If the pile is not removed in its entirety, then a diver will be used to inspected and retrieve. Agent Perks stated that since they are in designated port area and replacing one for one, this is considered a *Request for Determination*. Chairman Audette requested to have a condition that if part of the pile breaks, a diver would need to be sent to retrieve the broken pieces. Agent Perks recommends a Negative Box 6.
