Nadeau Tree Service will remove five trees in total from my property. Three of these trees will be on the side of the house where there are a cluster of trees. One of them will be removed due to the tree hitting the side of the house and leaning over very substantially. The other two in the cluster will be cut down due to them being dead with no branches or leaves on them. The other two trees that will be cut down are right beyond my fence in the backyard. One of the trees is leaning substantially and uprooting the fence due the roots coming out of the ground. The other tree will be taken down as a precaution as I was instructed i will have the same problem with this tree in the not so distant future.

Tree 1 picture is showing the tree hitting the house and leaning; Tree 2 & 3 picture show the two dead trees; Tree 4 & 4.2 pictures show the tree uprooting the fence and leaning. Tree 5 shows the future problem tree
