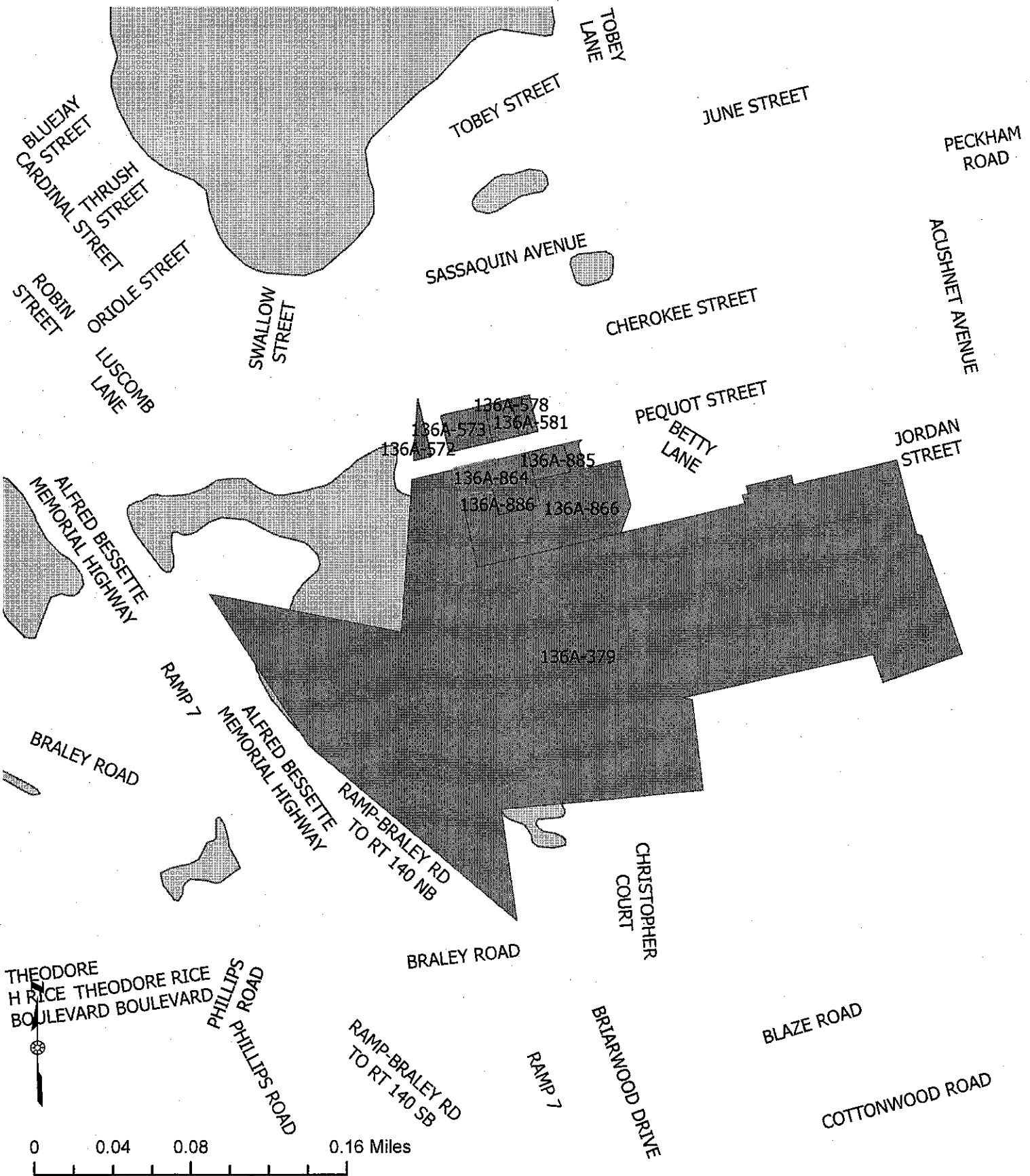
Dear Applicant,


