# **CALL MEETING TO ORDER**

Chairman Audette called the meeting to order at 6:30 pm.

### **NEW BUSINESS:**

# 1. 638 West Rodney French Blvd – Matt Bivens to discuss minor modifications to DoA.

Ms. Svetlana Bivens present tonight asking for a minor modification to the original *Determination of Applicability*. Agent Perks stated that they are putting up a couple of decks and extending their original plan by five more footings and reason for coming in front of the commission is that they are right on the line of the coastal flood zone. Would this require a new filing or can this be considered a minor modification and revised plans have been presented. Chairman Audette reminded that the original RDA storage of supplies and controls need to be meet and this does not eliminate those conditions.

Vice-Chairman Carney made a motion to approve the Minor Modification. Motion was seconded by Commissioner Blanchard. Vice-Chairman Sean Carney- Vote in favor. # 2. 1377 Sassaquin Ave. *Vegetation Alteration Application* – Dennis Audette looking to cut vegetation within 100ft buffer zone.

Vice-Chairman Carney read into record and asked if this was a continuation of the regular maintenance that Mr. Audette has been doing. Mr. Audette replied that it is and that the greenbrier had grown heavily this year.

Commissioner Linhart made a motion to approve the Vegetation Alteration Application. Motion was seconded by Commissioner Linhart Vice-Chairman Sean Carney- Vote in favor. Chairman Audette and Agent Perks suggested to the commission that a Vegetation Alteration Application be filed in order for Ms. Degbor to take care of the 13 trees in the Notice of Intent while they wait for the DEP number.

The applicant is submitting this after-the-fact NOI for paving a driveway and constructing a sand volleyball court and clearing within the 100ft Buffer Zone to a bordering Vegetated Wetland and in an area of Bordering Land Subject to Flooding. Applicant is installing stormwater retainment gardens onsite to account for paving in the buffer zone. Representative is William McGovern of Zenith Land Surveyors, LLC.



Mr. William McGovern present tonight representing Ian Yates. Mr. McGovern stated that he submitted a revised narrative with the changes to the plan from the comments made by the Commission from the last meeting involving the volleyball court, which the owner stated it is just a sand clearing and moving back the sand clearing that falls in Department of Conservation Recreation (DCR) owned land. Chairman Audette made it clear that Mr. Yates needs to be aware of the red property line, where his property and DCR owned property meet and he is not to build on DCR land. Chairman Audette suggested that a deadline of June 15, 2023 be added to the *Order of Conditions* for the completion of this project. Agent Perks recommends 2 special conditions be added to the *Order of Conditions*:

1. The completion date of June 15, 2023.

2. Work pulled back from DCR overreach area.

Commissioner Linhart questioned how they are going to cut the paved driveway. Mr McGoven stated they would saw cut it. Chairman Audette made note that once the paved driveway was cut, that area would need to be restored back to its original state, with natural vegetation. Agent Perks recommends an *Order of Conditions* with the *Standard Inland Special Conditions* and the 2 special conditions mentioned above.

Vice-Chairman Carney made a motion to issue an Order of Conditions with the conditions as recommended by the Agent. Motion was seconded by Commissioner Blanchard. 7. <u>SE049-0909</u> - A Notice of Intent as filed by James Clancy of Eversource Energy for property identified as Flaherty Drive New Bedford, MA (Map 133, Lots 62, 12, 10, 54,66). The Applicant is proposing to install entrenched underground conduit along their right-of-way (ROW) beginning at Flaherty Dr. and extending approximately 3,470 linear feet east. Additional infrastructure proposed to support the conduit includes manholes, riser poles, and pad mounted switch boxes. All work will occur within Eversource's existing ROW. Representative is Eileen Piskura of Kleinfelder. <u>CONTINUED TO 12/6/22</u>

Ms. Emma Mrowka of Kleinfelder present tonight along with James Clancy of Eversource Energy. Chairman Audette stated that there is a requirement that updated engineered plans be resubmitted along with a formal presentation about the project in front of the Commission as part of submitting a *Notice of Intent* in order to make a decision. Agent Perks asked for a better understanding of the stream crossing included in the presentation of this project.

1. A Request for Determination of Applicability as filed by Jose Matos for property identified 103 Willard Street New Bedford, MA (Map 11, Lots 2,3, & 90). The applicant is proposing the construction of a new deck structure within a mapped flood zone. Representative is Jose Matos.

Mr. Jose Matos present tonight requesting an *RDA*. Agent Perks read into record a letter from Ward 6 City Councilor Ryan Pereira voicing his support of this project. Chairman Audette requested that a special condition be added that the tubes be backfilled by Saturday November 26<sup>th</sup>. Agent Perks recommends an *RDA* with the special condition of backfilled be done by November 26<sup>th</sup>. Commissioner Blanchard had questioned if the project had already commenced, which Mr. Matos replied in the affirmative.

Vice-Chairman Carney made a motion to issue an RDA with the special condition recommended by the Agent.
