Determination of Historic Significance for Historic Resources Funded through CPA

Historic Resource Information

The Allen-Charette/Capitol Theatre at 1418-1440 Acushnet Avenue is a two-story brick block that occupies the northern two-thirds of the frontage on the east side of Acushnet Avenue between Deane and Bullard streets.



The Allen-Charette building, housing the Capitol Theatre, first-floor retail space, and second-floor office space, was built in 1920. The front façade contains six street-level storefronts a long row of windows for offices above that concealed the 1580-seat Capitol Theater running the full length of the building in the rear. The southernmost storefront originally served as the entrance and promenade to the theater lobby, which is indicated by the stone sign block cast with "Capitol" in the parapet above the second story.

Thomas J. Charette partnered with George W. Allen Jr. in building the Capitol Theatre and became the largest owners and managers of theatres in the city. The 1580-seat Capitol Theater was their largest when it was built. It is likely that the building was designed by LeBrode & Bullard, New Bedford architects and mill engineers. The interior designer of the theater is not known.

The building combines retail, office and theater functions in a compact, two-story urban building. Exterior decoration is modest and economical; the theater interior was designed in a restrained Neoclassical style focused primarily on the stage proscenium. The interior of the theater is intact with the exception of the sloping floor, which has been cleared of its seats and flooring.

The Allen-Charette/Capitol Theatre is significant for its historical association with and contribution to the rapid development of the Acushnet Avenue commercial corridor that took place at the turn of the twentieth century in response to the spread of textile mills and the subsequent exploding population of mill workers in the North End. It has historical associations with the growth and development of the entertainment industry over the twentieth century. It contributed to the explosion of movie house establishments in New Bedford during the first quarter of the twentieth century, a development that was mirrored in cities across the country. Additionally, the Capitol Theater building is significant for its associations with the ethnically diverse population of the North End.

The Allen-Charette/Capitol Theater building is architecturally significant as a representation of a mixed-use American commercial style building and is as one of the few surviving theater buildings in New Bedford. The Capital Theatre interior has undergone alterations, but retains much of its architectural detail, including the stage proscenium.

The Massachusetts Historical Commission has concurred with the Preservation Planner's CLG Opinion that the Capitol Theatre is eligible for listing in the National Register. **SEE ATTACHED CLG OPINION.**
