In addition, the proposed concept will include handicap parking near the designated area.

There are over 77 million Baby Boomers in the country in need of exercise to maintain their health so we believe its time to really think about the idea of "active aging" and give serious thought to the Outdoor Adult Fitness Equipment" concept which would be accessible to adults, seniors, people with disabilities and young adults. The U.S. continues to have the highest rate of obesity and other diseases related to obesity, The Dept of Health and Human Services estimated that due to obesity alone, the cost for preventative health consequences could reach \$117 billion. This project would be a win-win for everyone in the city of NB and meets at least three of the CP goals and criterion: Its located in a historic area, it recreational and will be in the open air as we "take it outside" and make exercising more accessible to all.

The exercising equipment will be state of the art and will add to the beauty of the park.
