**Project Location:** 105 Rockdale Avenue (Map 18, Lot 69)

**Overview of Request:** The petitioner has installed nine vinyl type large signs on the location listed above. The petitioner was denied a building permit for installing a billboard without a permit. The petitioner appeals on the belief that the type of signage installed on the building are not prohibited signs and do not fall under the category of a billboard. The petitioner states they are banners.

### Information for Consideration:

- Billboard Definition: "An accessory or nonaccessory, changeable copy sign erected for the purpose of advertising a product, event, person or subject not entirely related to the premises on which the sign is located, and upon which the advertising message is painted or posted with printed art panels.
  - On-ground billboard: A billboard which is supported by one or more columns, poles, uprights or braces, in or upon the ground which is not a direct part of a building.
  - On-structure billboard: A billboard which is attached to and is therefore a direct part of a building."<sup>1</sup>

- Petitioners Appeal: The petitioner appeals on the belief that the type of signage installed on the building are not prohibited signs and do not fall under the category of a billboard. The petitioner states they are banners.
- Power of the Zoning Boards of Appeals: The Zoning Board of Appeals is the board to hear and decide appeals taken by any person aggrieved by his/her ability to obtain a permit or enforcement action from any administrative officer under the provisions of M.G.L.A c. 40A, subsection 7, 8, and 15.
- **Determination of the Board:** In this case the Board is to determine if the signs installed at this location fall under the definition of "Billboard" and are therefore a prohibited signs type.

#### **Conclusion:**

In light of our review of the entire petition, accompanying materials, and a visit to the site, staff noted the following. The installed signage does not contain any logos of the company. Wording found on the images are: "Your Storage Place" and "lift". The images are of children playing soccer on the southwest corner of the building, and three images of young women moving items and/or posing in a self- storage facility on the southernmost side of the building. The Signage would seem to be temporary in nature as it is lightweight and of limited durability material.
