Opening of FY22 CPA Plan Review Public Hearing

Welcome and Introduction

Chair J. daSilva welcomed all and asked all in attendance to direct all comments to the Chair. She explained this hearing was to review the plan draft and the purpose of the plan. She introduced J. Bailey, CPA Coordinator, who presented the PowerPoint presentation.

Presentation of FY22 CPA Plan Draft

- J. Bailey welcomed all and explained the purpose of the hearing. The hearing was being recorded to be available on the New Bedford Cable Access website. J. Bailey gave an overview of CPA in New Bedford, the CPA categories, and the plan. She explained the CPC is required to update the CPA plan annually. The Plan outlines the City's priorities and goals for the fiscal and serves as the guide by which the CPC reviews the applications. In addition, the Plan contains the application packet.
- J. Bailey reviewed the three CPA categories and how the public can provide input into the FY22 plan. The goals and priorities are incorporated into the review process and used to score each application. The tentative FY22 timeline was reviewed. J. Bailey invited the public attending to provide comments until July 9, 2021. She reviewed the materials posted on the CPC webpage on the city website.
- J. Bailey invited members of the public in attendance to ask questions or provide comments. J. daSilva explained project applications come from the public and the CPC is available to assist any individual or organization with a project idea. J. Bailey stated the CPC is aware of the need to fund projects in all wards provided applications from all wards are received.

Lisa Netts asked if the CPC knows how a project awarded funding turns out. J. daSilva explained the process which includes a project closeout report and a site inspection by J. Bailey. J. Bailey stated there have been 63 grants awarded to project throughout the city. The report is submitted with the project's final disbursement. All CPA plans are available on the CPC webpage.
