Presentation of FY23 CPA Plan Draft

- J. Bailey welcomed all and explained the purpose of the hearing. The hearing was recorded to be made available on the New Bedford Cable Access website. J. Bailey gave an overview of CPA in New Bedford, the CPA categories, and the plan. She explained the CPC is required to update the CPA plan annually. The Plan outlines the City's priorities and goals for the fiscal and serves as the guide by which the CPC reviews the applications. In addition, the Plan contains the application packet.
- J. Bailey reviewed how the public can provide input into the FY22 plan. The goals and priorities are incorporated into the review process and used to score each application. J. Bailey invited the public to provide comments until July 15, 2022.
- J. daSilva invited members of the public in attendance to ask questions or provide comments. There were no questions or public comments.
