## **NEW BUSINESS - APPEARANCES/ACTIONS**

1. Whalers Football to discuss concession Stand at Lot 13.

The NB Whalers have raised \$30,000 in funds. Peter states plans needs to be designed {stand-delete}. Applied for CDBG Grant total for work should be around \$150,000. Mayor Mitchell has approved in-kind service for Water and Sewer. Christian Farland is working on plans and they will need to come back in front of board at a later date with plans. Mayor Mitchell decided that the stand should be placed near the parking spaces.

2. American Cancer Society Relay for life New Bedford 6/23-6/24
