Adult Soccer League Liga Maya Permit at Morton Ave Field.

Peter Boswell read a letter from Captain Derek Belong of the New Bedford North End Police
Department. This letter went into details about all the issues that have been happening in the
neighborhood of Morton Ave during the time frame that the Liga Maya is on the field. Captain Belong's
letter details several issues such as illegally parked cars, players/spectators drinking, and others. Five
arrests were made and Captain Belong is requesting that their permit to operate be suspended
immediately. The Board spoke with Anibal and the representation of the security firm about their
security plan and suggested more security may be needed. The Board asked Anibal to contact the New
Bedford Public Schools regarding access to a larger field for their games. The Board requested a
mandatory meeting. The Board told the league to respect the neighbors. Anibal explained that they do
their best to respect the rules including canceling the games the weekend of Cinco De Mayo to avoid
large crowds. If coaches or players drink, they must forfeit the game. A mandatory meeting is to be
scheduled to reinforce the rules and regulations for all the teams with every team coach, Anibal, Capt.
Belong, Pete Boswell, and other interested parties to review the rules and regulations and discuss
concerns raised by Capt. Belong. The board is requiring that two more security guards are added. The
permit is suspended until the meeting and additional security is in place.
