1. Whaling City Golf Course to discuss plans & rates for 2023

Invitee: Sue & Bruce Carlson

Sue & Bruce Carlson gave a review of the year at the Whaling City Golf Course for 2022. The Carlson's brought a packet for review which included their Annual Report for 2022 & a breakdown of all the fees for 2023. The Carlson's are keeping the 12-minute t-times for the golf course & have had a lot of positive feedback for that. The Carlson's would like to raise the fees by \$2.00 for 9 holes & \$4.00 for 18 holes. Peter Boswell & Justin Ohlson have heard personally from folks who have used the course & are pleased with how it's being run. Peter Boswell congratulated the Carlson's on their success running the Whaling City Golf Course & said the Whaling City Golf Course is one of his prides of being on the Park Board. 2. Coastal Foodshed Inc. Signage @ the Buttonwood Community Center

Maisy McVicar brought a photo of ideas that Coastal Foodshed has for signage at the Buttonwood Community Center. The Farmer's Market will use the signage to advertise about the Farmers Market.
